Summer School Policies & Procedures

The Tomball ISD secondary summer school program is designed to provide an opportunity for students to repeat courses failed for make-up credit or to take courses for original credit. Students may take one semester of one course per session (1/2 credit) and earn a maximum of one high school original credit. Make-up credits are offered through our self-paced Grad Lab, and it is possible for students to make up more than one semester of one course per session based on their efforts. Make-up credit is only available for repeat credit courses. Original credit is not offered through our Grad Lab.

Who May Attend

Students enrolled in grades 9-12 during the 2018-2019 school year may attend.



Curriculum

- Core courses for grades 9-12 will be offered for make-up credit.
- Courses will be offered for original credit in Economics, Government, Health, Media Literacy (Speech credit), and PE, providing the minimum number of students (**15**) enroll in the course.

Transportation

Transportation is **NOT** provided for secondary summer school.
