1. Application for preschool can be found on the Shelbyville Central Schools' website at [www.preschool.shelbycs.org](http://www.preschool.shelbycs.org) under PARENTS.
2. Class assignments will be made on a "first come, first served" basis and upon a completed application.
3. Completed application includes:
  - **Completed application**
  - **Copy of birth certificate**
  - **Copy of immunization records**
  - **Home Language Survey**
  - **Registration Fee-\$50.00**, checks made payable to Shelbyville Central Schools
  - **Proof of residency**-may be one of the following: utility bill dated within the past 30 days, payroll stub with current address within the past 30 days, copy of rental lease and record of most recent rent payment, copy of title work or closing papers from recorder's office, unemployment check or welfare/government check with current address within the past 30 days. Proof of residency does not apply to homeless students per the McKinney-Vento Act.
  - If out of district – must complete an out of **Out of District Transfer Request**. This form can be found at [www.preschool.shelbycs.org](http://www.preschool.shelbycs.org) under PARENTS tab.
4. **RETURNING** preschoolers from the 2018-19 school year will only need to provide an application and registration fee.
5. A confirmation letter will be sent out to each parent in March.
