SOPHOMORE CONTRACT

Participation in Canyon Springs High School activities is a privilege. All students should conduct themselves responsibly. Sophomores should exemplify good behavior, attendance, and academic standing. School staff fully anticipates responsible actions by each tenth grade student; however, should infractions in attendance, discipline, and academic policies occur, the following procedure will be utilized (see both sides of this contract):

BEHAVIOR

First referral: The student and parent(s) will be required to meet with their administrator to discuss the cause for the referral. The student's behavior file will be "flagged" to indicate current discipline status. If necessary, the administrative cabinet will meet to review the infraction and determine if the student will be allowed to participate in any student school activities (such as Homecoming Dance, Winter Formal, and Prom*).

Second referral: The student has clearly violated the Sophomore Contract and the student will NOT be allowed to participate in any school activities, including but not limited to, Winter Formal, Prom*, ASB, field trips, and athletic events (as a spectator or participant).

Suspension: Any sophomore who violates the Education Code and is suspended from school has clearly violated the sophomore contract. The student will NOT be allowed to participate in any student school activities, including but not limited to, Winter Formal, Prom*, ASB, field trips, and athletic events (as a spectator or participant).

ACADEMIC (GRADES)

Students must maintain a 2.0 GPA. If the student's GPA drops below a 2.0, the student will not be eligible for student school activities, including, but not limited to, Winter Formal, Prom*, ASB, field trips, and athletic events (as a spectator or participant) and will be required to comply with the interventions identified by a counselor, teacher, and/or administrator.

ATTENDANCE

Students must maintain a 95% or greater attendance rate. Students are required to attend school and must maintain 5% or less tardies and unexcused/uncleared absences. If a student does not maintain 95% or greater attendance, then the student will not be eligible to participate in school activities (such as Homecoming Dance, Winter Formal, and Prom*) and school athletic events; in addition, the student will be placed on an attendance contract.

CONSEQUENCES

Participation in the Canyon Springs High School activities is a privilege, not a right. The preceding requirements and guidelines must be met for participation in all school activities.

If any student violates this contract after paying for an event, **NO FEES WILL BE REFUNDED.**

If misbehavior occurs at an activity, the student will be removed immediately.

*Sophomore and Freshmen students are only allowed to attend Prom as a guest of a Junior or Senior; a guest pass is required.
