Re: Nutrition Services Food Products Bid November 2016 Award Recommendations

Attached you will find our recommendations for awards of the Nutrition Services bids for Food Products for the period January 1 through June 30, 2017.

The award recommendations are generally based on bid price rankings, with the low bidder deemed the winning bidder, and all other things considered equal. Where award recommendations do not strictly follow this low-bid criterion, we have provided respective explanations for the alternative recommendation.

In the case of several items, a bidder was not ranked and is thus not considered for award. Often this is due to the unranked bidder offering a product other than was specified, though other conditions may cause this ranking exclusion. In some cases, those unranked bids were the low bid submitted. Where a bid was not ranked and not considered, an explanation is provided in the award packet; this explanation is provided for all unranked bids, not only those that would have been the low bid.

Between the times of bid item list generation and bid evaluation, Nutrition Services experienced a problem with NutriKids, the software package used to manage inventory and generate bid packages. This problem caused a rebuilding of inventory records, and some items featured on this Food Products bid will have had their inventory numbers changed. While this may create some confusion in sorting items, we do not see this problem as damaging to the bid process. All items included in the original bid list are included in the bid evaluation; while some particular inventory numbers may have changed, neither descriptions nor the items have changed. In our judgment, this issue has no material effect on the bid or bid process and should not have effect on the bid award. A list of those items affected, featuring both the original and new item numbers is included.

Please advise us if any further explanation is necessary regarding these recommendations or the bid process.

1. You are hereby invited to submit a bid for **Food Products** for the Nampa School District No. 131 for the spring semester of the 2016-17 school year.
2. Sealed bid must be received by Nampa School District at or before **1:00 pm Mountain Time, Tuesday, November 29, 2016** in the office of the Clerk, 619 South Canyon Street, Nampa, Idaho 83686. Any bids received after this time and date will be returned unopened to the sender. The bids will be publicly opened at the stated date and time in the Nampa School District No. 131 Office, 619 South Canyon Street, Nampa, Idaho.
3. All bids or proposals must be made on the forms supplied and filled in completely. The bid must be appropriately signed in ink.
4. Any bidder may withdraw their bid at any time before the bid opening by either written request or in person. **No bid may be withdrawn after the time of opening.** The school district may require a performance bond of the successful bidder if such is deemed to be in the best interest of said school district.
5. Bid prices are to be held for six (6) months from **January 1, 2017 through June 30, 2017.**
6. **Line Item vs. All or Nothing Bid Award:** Nampa School District, Nutrition Services Department bids are “line item” bids. The Nampa School District reserves the right to award “all or nothing” bids that are deemed to be in the best interest of the school district.
7. The Board of Trustees reserves the right to accept or reject any and/or all bids and waive any formality that is deemed to be in the best interest of the school district.

Bid Award Objection Procedures

Any participating bidder may object to a bid award, pursuant to the requirements of Title 67, Chapter 28, Idaho Code.

A bidder who wishes to object a bid award must do so within seven (7) calendar days of the posting of the award. This objection should be submitted, in writing, to the District's coordinating party as listed in the publicly posted bid documents specifying bid items, procedures, and other requirements. The objection must set forth the express reason(s) for the objection and why the award has been made in error. Upon receipt of a proper objection, the governing party for the bid in question will stay its award decision and any procurement under the award until it has addressed the particular objection(s) submitted.

The governing party shall review its decision and will determine to (1) affirm the award, (2) modify the award, or (3) repeat the bid process, setting aside its award, and will set forth its reasons therefor. After completion of the review process, the District may proceed as it deems to be in the best interest of the District.

For the purposes of bid objections, the governing party shall be whatever person or group is duly empowered and qualified to make an award, under procurement laws and guidelines set forth by the State of Idaho for political subdivision purchasing and Nampa School District purchasing rules.
