- * The Board approved the January 17, 2018 bill list in the amount of \$4,057,607.16.
- * The Board approved the Secretary and Treasurer Reports for month ending November 30, 2017 for the 2017-2018 school year.
- * The Board approved transfers for November 2017 in the amount of \$216,626.70.
- * The Board approved student(s) on home instruction for the 2017-2018 school year.
- * The Board approved a general education send/receive tuition contract in the amount of \$13,500 from September 1, 2017 to June 30, 2018 for a Livingston student to attend school at the Hackettstown High School.
- * The Board approved a special education tuition contract in the amount of \$7,862.40 (2.88 hours/day for 182 days at \$15/hour) for Resource and In Class Support Services from September 1, 2017 to June 30, 2018 for a Livingston student to attend school at Hackettstown High School.
