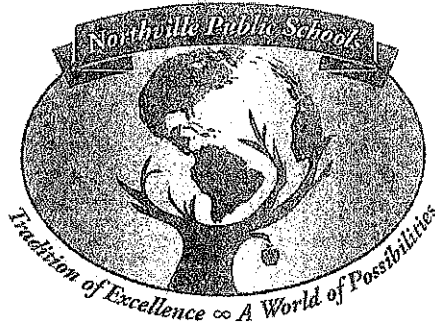
### Chaperone ~ Optional
