For all incoming girls and boys grades 1-5 will be working on the basic techniques needed to excel in wrestling. Emphasis will be placed on high percentage scoring techniques from the neutral, top, and bottom positions.

Wrestlers in grades 6-12 will be exposed to the same level of high percentage scoring techniques, with the emphasis placed on the higher level setups and finishes.

This camp is to emphasize chain wrestling. A wrestler needs to complete a series of moves without thinking. We will help wrestlers to pick several series of chain moves to fit their style.
