ELIGIBILITY APPLICATION FOR 2019/20 SCHOOL YEAR

PLEASE READ THOROUGHLY AND KEEP FOR ADDITIONAL INFORMATION

We are now accepting applications for the SJUSD State Preschool Program for the 2019/2020 school year. The program is available free of charge to eligible families. Eligibility is determined by family income, size, and the age of the child. Families who meet the eligibility requirements for the program will be placed on an eligibility list.

Where is the Program Offered?
The State Preschool program is offered at Baldy Mesa, Heritage, Phelan, Pinon Hills, Vista Verde, and Wrightwood Elementary School. Classes meet from 8:05 a.m. to 11:05 a.m. on all regular school days. Additional afternoon classes are offered at Baldy Mesa and Vista Verde from 11:50 a.m. to 2:50 p.m.

Who can attend State preschool?
Children who will have their 3rd or 4th birthday on or before September 1, 2019 are eligible to attend. There are limited spaces available at some school sites for families who exceed the income ceilings and are willing to pay the daily rate of \$29.90. Please contact us for more information if you are interested in this option.

Please be advised that we do not offer a toilet training program.

All students in the State Preschool Program must be completely toilet trained.

APPLICATIONS

To be placed on the eligibility list, please complete an **eligibility list application**. Families will be contacted according to the ranking and priority for an appointment if spaces are available at the school site selected. Eligibility appointments for three-year-old children will not be scheduled until after all eligible four-year-old children have been enrolled.

Please note that you are applying to be placed on an eligibility list and that completion of the application does not enroll your child in the State Preschool program. Enrollment appointments are only conducted if there are openings in the program.

ADMISSION PRIORITIES

First Priority:

Child Protective Services Referrals for 3 & 4-year-old children regardless of income.
Children who will be four (4) years old on or before September 1, 2019.

Second Priority:

Children who are going to be three (3) years old on or before by September 1, 2019.

Families with lowest income shall be admitted first.

REQUIRED DOCUMENTATION

Applicants must provide documentation at the time of enrollment that demonstrates eligibility for the State Preschool program. Some of the required documentation includes but is not limited to:

- ✓ Birth Certificate or baptismal certificate for each child listed in the family size
- ✓ Income verification for all adults counted in the family size
- ✓ Proof of residency
- ✓ Photo ID for enrolling parent/guardian
- ✓ Proof of enrolling child's immunizations
- ✓ Proof of physical exam completed within the past calendar year

Ahora estamos aceptando solicitudes para el programa preescolar estatal SJUSD para el año escolar 2019/2020.

El programa está disponible de forma gratuita para las familias elegibles. La elegibilidad está determinada por el ingreso familiar, el tamaño y la edad del niño. Las familias que cumplan con los requisitos de elegibilidad para el programa serán colocadas en una lista de elegibilidad.

El programa estatal preescolar se ofrecen en Baldy Mesa, Heritage, Phelan, Pinon Hills, Vista Verde y Wrightwood Elementary School. Las clases se empiezan de 8:05 a.m. a 11:05 a.m. en todos los días escolares regulares. Se ofrecen clases adicionales por la tarde en Baldy Mesa y Vista Verde de 11:50 a.m. a 2:50 p.m.

Niños que tendrán su tercer o cuarto cumpleaños en o antes del 1 de septiembre de 2019 son elegibles para asistir al programa Estatal Preescolar. Hay espacios limitados disponibles en algunas escuelas para las familias que exceden los techos de ingresos y están dispuestos a pagar la tarifa diaria de \$29.90. Llame para obtener más información si está interesado en esta opción.

APLICACIONES

Para ser incluido en la lista de elegibilidad, complete una solicitud de lista de elegibilidad. Se contactará a las familias de acuerdo con el ranking y la prioridad para una cita si hay espacios disponibles en el sitio escolar seleccionado. Las citas de elegibilidad para niños de tres años no se programarán hasta después de que todos los niños elegibles de cuatro años hayan sido inscriptos.

Tenga en cuenta que está solicitando que lo incluyan en una lista de elegibilidad y que la finalización de la solicitud no inscribe a su hijo en el programa preescolar estatal. Las citas de inscripción solo se llevan a cabo si hay vacantes en el programa.

PRIORIDADES DE ADMISION

Primera prioridad:

Referencias de servicios de protección infantil para niños de 3 y 4 años, independientemente de los ingresos.

Niños que tendrán 4 años el 1 de septiembre de 2019 o antes.

Segunda prioridad:

Niños que tendrán 3 años el 1 de septiembre de 2019 o antes.

Las familias con ingresos más bajos serán admitidas primero.

DOCUMENTOS REQUERIDOS

Los solicitantes deben proporcionar documentación al momento de la inscripción que demuestre elegibilidad para el programa preescolar estatal. Algunos de los documentos requeridos incluyen, pero no están limitados a:

- ✓ Certificado de nacimiento o certificado de bautismo para cada niño enumerado en el tamaño de la familia
- ✓ Verificación de ingresos para todos los adultos contados en el tamaño de la familia
- ✓ Prueba de residencia
- ✓ Identificación con foto para inscribir padre
- ✓ Prueba de la inscripción de las vacunas del niño
- ✓ Comprobante de examen físico completado dentro del año calendario anterior
