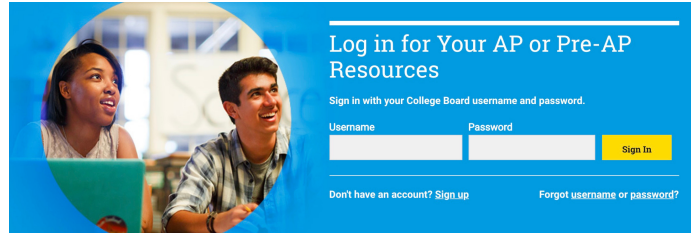


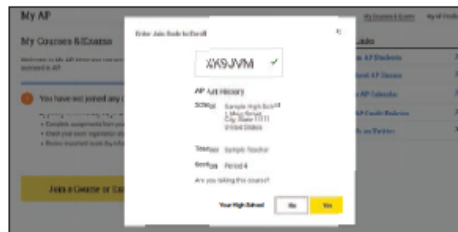
Point Loma HS 2019-2020 AP® Exam Registration

New AP® Course Resources for 2019-2020:

- ➔ All students will be able to join a FREE online College Board AP® 'Course' Group on The College Board MyAP Site at <http://myap.collegeboard.org> in September 2019 (Students will need a College Board Account to Join the AP® online group.)



- ➔ Students will receive a 'Join Code' from their AP teacher to join the online group and be able to access instructional materials and resources as well as assignments such as review quizzes and tasks that teachers assign in the MyAP system. 'Join Codes' are specific to the subject, teacher and class period. Teachers will be distributing these Join Codes most likely once add/drop deadlines have passed.
- ALL students are encouraged to complete the 'Join Code' step with the code from their teacher to access the FREE online resources to use throughout the course of the school year as a preparation and review tool.



New AP® Exam Order Deadlines/Procedures for 2019-2020:

Students who are selecting to take the optional AP® Exam corresponding to their AP® courses will need to complete the following **additional** steps between Sept 10 and October 30, 2019.

- ➔ **STEP 1:** Submit a \$40 per exam deposit for the exam(s) that you are choosing to take at <http://aptsusa.com/pointloma> by **October 30, 2019**.
- ➔ **STEP 2:** JOIN the AP® Exam Group on The College Board's MyAP website (see above) by **October 30, 2019**. Complete the MyAP Registration Profile on the MyAP site with contact details, school of enrollment, etc.
 - (TIP: Enter your full legal name to match your school records, use an email address that you check regularly, and also make sure to enter your PLHS Student ID number.)
- 🕒 **(BOTH Steps 1 & 2 MUST be completed by Oct 30, 2019 to complete an AP® exam order activation.)**
- ➔ **Step 3:** Pay Balance Due: You'll receive a custom invoice via email from APTS for the balance of fees due for your exams. To be eligible to sit for the exams in May, the balance of fees must be paid in full by February 15, 2020.

Frequently Asked Questions:

When will the registration window be open?

- The Exam registration window is September 10 - October 30, 2019 for the May 2020 exams.
- Penalty fees of \$40 per exam apply to orders initiated late- Register early!

Why do I need to do a deposit in the fall?

- The ordering deadline for exams is now in the fall, but PLHS recognizes that not all families will be able to submit the full cost of fees in October. By submitting a deposit you have a secure exam, and then you and your family have time to plan to submit balance of fees due.

What if I didn't get a Join Code?

- Join Codes will be distributed by the AP® Teachers in September. Join Codes are subject, teacher and class period specific. Most teachers will distribute these codes in class after the add/drop period ends. Please complete the step by October 30, 2019. ALL Students should complete this step, even if they are not intending to take the exam, so that they can access the free resources course resources.

What if I can't log into my College Board account?

- Don't create a new one! Each student should have only ONE College Board account which houses AP®, PSAT® and SAT® scores and information. For log in help visit:

What if I drop the AP® Course(s) and no longer want to take the exam?

- You will need to contact cancel@aptsusa.com by April 30 to cancel the exam. A full refund is possible until October 30, 2019; Your \$40 deposit will be retained for cancellations between October 30, 2019 and March 1, 2020.

What if I want to add an exam AFTER the October 2019 deadline?

- A penalty fee of \$40 per exam will be assess. No new orders will be allowed after March 1, 2020
