



# QUAKER VALLEY SPORTS HALL OF FAME

## NOMINATION GUIDELINES

### I INDIVIDUAL ELIGIBILITY

#### A. Student-Athlete

1. Must be a graduate of Quaker Valley High School\*.
2. Must have participated in varsity athletics at Quaker Valley High School.
3. Must be graduated for a minimum of 10 years.

#### B. Coach

1. Does not have to have participated in athletics at Quaker Valley High School.
2. Does not have to be a Quaker Valley High School graduate.
3. Must have made outstanding contributions to Quaker Valley athletics.
4. Must be retired as a Quaker Valley head coach or have served as a head coach for a minimum of 15 years.

#### C. Contributor

1. Does not have to have participated in athletics at Quaker Valley High School.
2. Does not have to be a Quaker Valley High School graduate.
3. Must have made outstanding contributions to Quaker Valley athletics.
4. These contributions may be for service, donations, loyalty, longevity and general support of Quaker Valley athletics.

### II TEAM ELIGIBILITY

- A. The Hall of Fame Selection Committee may choose to honor one or two outstanding teams each year. This does not have to be an annual induction.
- B. This team must have participated in varsity athletics at Quaker Valley High School.
- C. The team(s) honored must have made a significant contribution to Quaker Valley athletics and the Quaker Valley community.
- D. There must be at least 10 years since this team last participated and made their contribution.

### III CRITERIA for SELECTION of POTENTIAL INDUCTEES

- A. Athletic achievement as a participant, coach or team.
- B. Personal accomplishments since graduation.
- C. Contributions individual has made to the Quaker Valley community or their own community since graduation.
- D. Individual must attend the induction ceremony to be eligible. If deceased, there must be a representative for the deceased. If a team is honored a representative or representatives must be present.

#### **IV PROCESS for SECURING NOMINATIONS**

- A. Nominations are open to be received from the public and limited to two per person per year.
- B. Nomination form must be completed online or mailed to the Quaker Valley Sports Hall of Fame by the deadline date.
- C. Any nomination form received after the deadline date will be held for the following year.
- D. Nominations will be retained for consideration for 5 years.
- E. Once nomination forms are received additional information may be requested from the Hall of Fame Selection Committee.

#### **V VOTING PROCEDURE**

- A. A Hall of Fame Selection Committee appointed by the Athletic Department will elect the Inductees from the available nominations.
- B. A minimum of 5 and a maximum of 10 candidates will be inducted each year.

#### **VI HALL of FAME SPECIAL RECOGNITION AWARD**

A, In any given year, the Hall of Fame Selection Committee may choose to present a Special Recognition Award. This award can be presented to anyone group or individual the Committee feels is deserving of such an award.

**\* Quaker Valley and mention of Quaker Valley High School is also meant to include graduates and athletic participants of Sewickley and Leetsdale High Schools.**
