

**Nonresident Guardian Affidavit** (For Nonresident Parents who are temporarily living with a Franklin Lakes Resident) Affidavit to be completed by Franklin Lakes Resident providing temporary housing.

The Franklin Lakes Board of Education shall operate the schools of this district for the benefit of all children residing in the district and such others as may be admitted, pursuant to statute and policy of the Board. The Board reserves the right to verify the residency of any student and the validity of any affidavit of guardianship. Documentation required to prove eligibility to attend the schools of this district shall be in accordance with policy 5111 Admission and policy 5118 Nonresidents and the administrative code.

Enclosed is an affidavit to be completed by the Franklin Lakes resident who is acting as the applicant/guardian of the child(ren) who are being registered to attend school in Franklin Lakes. The registration process will not be finalized until the completed, notarized form is received and proof of residency is established (copy of driver's license, utility bill, etc.). Failure to provide this information will further delay the registration process and school attendance will be subject to nonresident tuition.

Please note that this affidavit is good for one year; if temporary residency goes beyond the school year, a new affidavit will have to be completed. Once permanent residency occurs, you will need to contact your school and the Board of Education with your new address. Your permanent address in Franklin Lakes will determine which elementary school (if applicable) your children will attend.

This affidavit is made specifically to induce the Franklin Lakes Board of Education and the principal of the school to accept the said child as a legally qualified student in the Franklin Lakes Public Schools and without payment of tuition, knowing that the principal of the school and the Franklin Lakes Board of Education will rely upon the truth of the statements herein contained.

We fully understand and agree that:

- A. ANY FALSE OR FRAUDULENT STATEMENTS, ANSWERS OR DECLARATIONS CONTAINED IN THIS AFFIDAVIT OR IN THE SAID APPLICATIONS FOR ADMISSION, HERETO ANNEXED, MAY RENDER US PERSONALLY LIABLE TO THE FRANKLIN LAKES BOARD OF EDUCATION FOR PAYMENT OF TUITION.
- B. IF WE FRAUDULENTLY ALLOW THE SAID CHILD TO USE OUR RESIDENCE AND ARE NOT THE PRIMARY FINANCIAL SUPPORTER OF SAID CHILD WE WILL HAVE COMMITTED A DISORDERLY PERSONS OFFENSE AND UPON CONVICTION THEREOF WE MAY BE PUNISHED BY A FINE OF NOT MORE THAN \$1,000.00 OR BY IMPRISONMENT FOR NOT MORE THAN SIX (6) MONTHS OR BOTH.
- C. ANY FALSE STATEMENTS, ANSWERS OR DECLARATIONS CONTAINED IN THIS AFFIDAVIT OR IN THE APPLICATION FOR ADMISSION, HERETO ANNEXED, MAY SUBJECT US TO CRIMINAL PROSECUTOR FOR THE CRIME OF FALSE SWEARING IN VIOLATION OF N.J.S.A.2C:28-2 AND UPON CONVICTION THEREOF, WE MAY BE PUNISHED BY A FINE OF NOT MORE THAN \$75,000.00 OR BY IMPRISONMENT FOR NOT MORE THAN EIGHTEEN (18) MONTHS OR BOTH.
