## Minutes

Mr. Jenkins called the meeting to order and Mrs. Priester gave the invocation.

In accordance with the SC Code of Laws, 1976, Section 30-4-80 (d), as amended, the media has been notified of the time, date and place of this meeting (WBHC Radio Station and the Hampton County Guardian). In addition, the official agenda has been posted at the District Office.

Mr. Jenkins welcomed the public to the board meeting. There was no media present.

The Pledge of Allegiance was led by Mrs. Smith.

The Cafeteria Plan was discussed and will come in as a private vendor during the month of October.

Mrs. Priester moved to approve the recommendation of Dr. Wilcox to adjust the transfer fees policy as follows: The first child will be at 100%, the second child and thereafter would be reduced by 10% for each additional child. The motion was seconded by Mr. Murdaugh. The motion was passed unanimously.

Mr. Strother moved to approve the recommendation of Dr. Wilcox to proceed with Roof Maintenance Organization, LLC for \$13,000. Mrs. Murdaugh seconded the motion. The motion was passed unanimously.

There are not enough items of value for the surplus sale. We will take a sealed bid for any persons interested and will sell at the highest bid.

The Board agreed with the additional work at North District Middle School.

The work at the Wade Hampton High School Cafeteria was agreed on for \$55,000.

Mr. Strother moved to enter into executive session to discuss a student discipline matter, personnel matter, and a legal issue. Mr. Murdaugh seconded the motion. The motion was adopted unanimously.

Mr. Murdaugh seconded the motion. The motion was adopted unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to approve the recommendation of Mrs. Kinard to hire Alison Loadholt for the position of teacher at Varnville Elementary School. Mr. Murdaugh seconded the motion. The motion was adopted unanimously.

Mrs. Murdaugh moved on behalf of the Board I present a motion to place Kristy Wood as discipline for ninth grade academy, Tyrone Blackburn as discipline for 10<sup>th</sup> and 11<sup>th</sup> grade, Ron Youmans at 12<sup>th</sup> grade discipline and graduation coach, and Betty Woodward as Vocational director and discipline for Vocational department. Mr. Murdaugh seconded the motion. The motion was adopted unanimously.
