The Bibb County Board of Education met in a Regular Session on July 9, 2019, at 5:00 pm in the Central Office. The Invocation was given by Mrs. Dailey followed by the Pledge of Allegiance led by Mr. McMillan.

Mr. McMillan made a motion to approve the agenda. Mrs. Dailey seconded the motion which passed unanimously.
