

Course Description: This one-year course examines the development of the Eastern Hemisphere with an emphasis on global studies. Using appropriate technology, students develop an understanding of current world issues and relate them to geographical, historical, political, economic, and cultural contexts. Students will develop, research, and answer compelling questions using various and cross-disciplinary source material. Students will construct organized arguments for various audiences and purposes using researched evidence and reasoning. Students will participate in rigorous academic discussions, emphasizing multiple viewpoints in which claims and evidence are acknowledged and critiqued. Students will take action on local, regional and global problems at various times and places. This course fulfills the eighth-grade social studies requirement.

I. Course goals:

1. To investigate, analyze and interpret historic/current events using a variety of resources and perspectives.
2. To identify the causes and effects of oppression in the fight for equality.
3. To connect how cultures develop, interact and change to create diversity.
4. To evaluate how trade and the economy have influenced individuals, societies, and nations.
5. To describe the development of government systems, policies and laws.
6. To explain the causes and impacts of the movement of people, goods and ideas.
7. To interpret global connections and their impacts on the individual and society.
8. To analyze how various components of society (political, economic, technological, social, and artistic) have changed over time.
9. To examine the causes and effects of conflicts, diplomacy and international relations.
10. To evaluate how being financially literate is beneficial to the individual and society.
11. To use disciplinary skills including information, media, technology, and multiple texts to demonstrate critical thinking.

Lessons will be designed to not only include Nevada State World Geography Standards, but also **Nevada Common Core State Standards for English Language Arts & Literacy** in order to improve reading, reading comprehension, and writing skills.

III. Course activities

Assessments:

- i. Approximately three (3) per quarter following a major unit.
- ii. Cheating on a quiz/test and or disrupting the testing environment will result in an **automatic zero** for the quiz or test.
- iii. No talking or other distractions will be allowed during the assessment period!

Assignments: Warm-ups activities, class work, review concepts, preparing projects, studying for tests/quizzes.

Homework:

- iv. If the students do NOT complete work during class then it is considered homework. All other work is given as needed for practice.

Quarterly Project:

- v. Students may be assigned at least one major project each semester
- vi. Students will receive at least two weeks notification of the assignment and its due date.

IV. Curricular programs: Students will be using technology to create, describe and teach throughout the school year. Some activities will require work to be done at home. Many activities will be done as a group and each member will have a specific task to complete. Their contribution is important for the group and their learning of the required content.

- v. Semester exams will not be administered early. Students who are absent may make-up their exams on the district approved make-up day.

How and when students will be advised of their grades

- xi. Parents and students are urged to check the Infinite Campus Portal for grades regularly.
- xii. Upon completion of the 3rd week of each quarter, students with either a “D” or “F” will be required to return a signed progress report by parent/ guardian.
- xiii. Progress Reports are distributed after 5th week of each quarter along with required parent signature sheets

Citizenship/behavior expectations

- xiv. Citizenship is taken very seriously here at Leavitt Middle School. Teachers expect the very best from their students every day. Students are expected to bring supplies to class, pay attention, stay on task, talk when appropriate, be respectful to all teachers and students, avoid nuisance items, such as cell phones and toys, and to not chew gum or eat in class. Students who cannot work within these expectations will have points deducted from their citizenship grades. Other actions which disrupt the learning environment of the classroom or other students will also be documented and points will be lost.
- xv. Below is the scale for citizenship. All reports of misconduct will be documented in the teachers' grade book. This way, both the students and parents will be able to check Infinite Campus Portal to see what his or her current citizenship grade is, and why points have been lost.

0-2- Outstanding

3-5 -Satisfactory

6-8 -Needs Improvement

9 or more- Unsatisfactory

- xvi. Once the behavior has been noted, the citizenship grade will not be changed due to better behavior for the remainder of the grading period.

Late Work policy –

- xvii. When a student is absent, he or she is allowed 3 days to make up any missed work. It is the student's responsibility to get work from the teacher.
- xviii. Late work will receive no more than 50% credit earned on the assignment.
- xix. Once a Unit of instruction has been completed and another Unit has begun, no work from the previous Unit will be accepted and will result in a zero.

Assessment retake policy - If a student receives a 65% or below on an assessment or corresponding percentage per the IEP/504, they have the opportunity for a retake. The assessment must be made up within 1 week of the assessment on an assigned day. All work must be completed In order to retake the assessment. The assessment average will be the final grade.

VII. Bring Your Own Device (BYOD) –

This year, at Leavitt, we want to encourage the daily use of technology in and out of the classroom to further enhance the educational experience. This will permit students to utilize electronic tablets (iPads, Kindle Fire, Samsung, etc.) laptops, and reading devices for educational purposes. **Cell phones only used at teacher approval.** Please be reminded that your student is responsible for the safety of their personal device and must utilize the district's WIFI to ensure their internet safety. All use of these devices will be for educational purposes and must be approved by the individual teacher.

Use of these devices will be limited to educational uses in the classroom. Students violating this rule may have the privilege revoked after 2 violations and it is reset after the beginning of each quarter.
