**Parent Agreement**

The school corporation will provide transportation for the afternoon classes at the Career Center in Valparaiso only. Students in courses at the Career Center are required to utilize the school corporation transportation. Exceptions to this requirement may be made on a case-by-case basis as determined by the principal. Due to parking limitations at the Career Center it is not possible to accommodate all students' vehicles. Students in the morning classes at the Career Center or in classes at other sites such as Portage, Wheeler, Ivy Tech, Boone Grove, or Don Roberts will be responsible for their own transportation. Therefore, authorization from the parent is needed for the student to drive to his or her vocational class or to participate in a carpool, should one develop.
