### **HJELSETH FAMILY LEADERSHIP SCHOLARSHIP**

1. Character and achievement exemplify the ideals of Life Christian Academy mission statement.
2. Character and achievement testify to the Lordship of Jesus Christ.
3. Evidence of academic success at a GPA of 3.5 or higher.
4. Students who have exhibited exemplary leadership qualities throughout their school experience at Life Christian Academy.
5. Students who have participated in Student Leadership Institute will be given strongest consideration for an award.
6. Students should be enrolled in grade 12 and been accepted to a university.

### **TAYLOR FERRIS MEMORIAL SCHOLARSHIP**

1. Evidence of academic success at a GPA of 3.0 or higher.

4. The same scholarship may be available to each student awarded a scholarship each year until the student graduates, provided he/she meets criteria 1-3 each of those years.

1. Students should be enrolled in grades 9 through 12.
2. Students must have been previously enrolled at Life Christian Academy for a minimum of 2 years prior to be considered for scholarship.

### **What is the Life Christian Foundation?**

The Foundation is a 501©3 non-profit organization formed to provide a perpetual source of revenue that supports Life Center and Life Christian Academy.

### **What are Endowment Funds?**

Endowment funds are designed to accept gifts of cash, bequests (testamentary gifts made through a donor's will), memorial gifts, and other tangible property. Endowment funds have been established so the fair market value of the donor's gift will remain intact and permanently appropriated to the fund. The resources given are invested in securities so only the income generated is spent.

The asset value (fund balance) is protected by the Life Christian Foundation policy whereby only a percentage of the fund may be spent in a given year. This policy allows opportunity for the continual growth of the fund and a continued return on investment—thus extending the life of the endowment fund. Each endowment fund is established with a fund agreement wherein the donor establishes the purpose for the fund and the criteria under which decisions are made for the use of the fund proceeds.

The income generated from the Endowment is used to fund scholarships and the scholarships on this application form are dependent upon the investment income.

### **How are Funds Managed and Invested?**

Columbia Trust is the investment manager for the Life Christian Foundation. We are fortunate to be associated with this fine organization.
