### 2019-20 SCHOOL MEALS PROGRAM (Free Breakfast and Lunch for All Students)

August 1, 2019

Dear Parent or Guardian:

Great news for you and your children! All students at **PARK CITY PREP CHARTER SCHOOL** can get a **FREE** healthy breakfast and lunch at school during the school year. What do you have to do?

- Must fill out “2019-20 Application for Free and Reduced-price School Meals or Free Milk”
- Must complete “Opt-In/Opt-Out School Meals Form” (In order to order the correct number of meals we must know whether or not your child will be eating a school breakfast and/or school lunch.)

Both of these forms can be found in the drop-down menu in the Parents section on our website. In addition we will be including them in the mailing regarding school buses which you will receive in the month of August.

Our school is getting free meals for all students as part of the National School Lunch Program (NSLP) and School Breakfast Program (SBP) through a choice for schools called the Community Eligibility Provision (CEP).
