

**SANTA CLARA COUNTY COMMITTEE ON SCHOOL DISTRICT ORGANIZATION**

**ESTABLISHMENT OF TRUSTEE AREA ELECTIONS  
IN THE CAMPBELL UNION HIGH SCHOOL DISTRICT**

**Background**

Education Code section 5019 provides that a county committee on school district organization may establish, rearrange, and/or abolish trustee areas and provides that a proposal to establish trustee areas may be initiated by a resolution of the board of trustees of a school district.

On July 25, 2019 the Board of Trustees of the Campbell Union High School District approved a plan and initiated the process with the Santa Clara County Committee on School District Organization to establish trustee area elections within the Campbell Union High School District.

Education Code section 5020 provides that a resolution of a county committee on school district organization approving a proposal to establish trustee areas, and to adopt one of the alternative methods of electing governing board members specified in Education Code section 5030, shall constitute an order of election which shall be presented to the electors at the next succeeding election of the governing board.

The Board of Education of the Campbell Union High School District passed a resolution on May 30, 2019 authorizing the Campbell Union High School District Superintendent to request from the State Board of Education a waiver of the requirements of Education Code section 5020, effective upon the establishment of trustee election areas by the Santa Clara County Committee on School District Organization.

In accordance with Education Code section 5019, the Santa Clara County Committee on School District Organization called and conducted at least one public hearing on August 12, 2019, within the jurisdiction of the Campbell Union High School District.

On August 12, 2019 following the public hearing, the County Committee on School District Organization approved the establishment of trustee areas within the Campbell Union High School District as set forth in the map attached hereto as Exhibit A by the following vote:

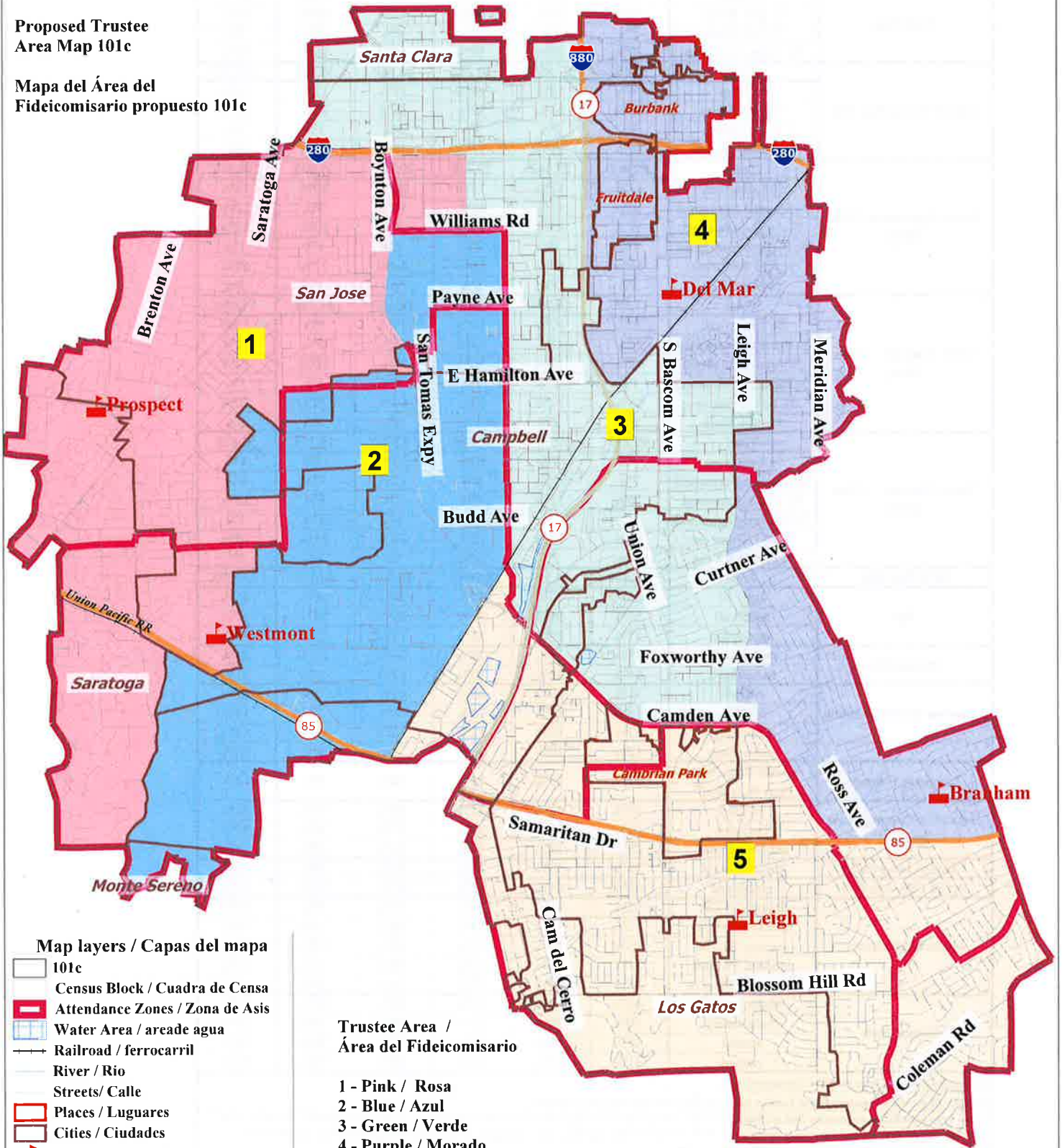
**Campbell Union High School District Trustee Area Plan**
