New fees effective July 1, 2019

Center for Early Education, El Rincon, La Ballona & Linwood E. Howe <u>Preschool- Ages 3-5</u>

This full-day, 12-month program, with a developmentally appropriate curriculum planned to meet each child's individual needs. The program is open from 7 a.m. to 6 p.m. Our curriculum addresses social, emotional, physical and cognitive needs. Care is available year-round. Monthly tuition is \$1,075.00 per child with a non-refundable \$100.00 Registration Fee. *Fees are based on enrollment, not attendance.*

Before School Program ~ School Age Only

Morning Care is offered at all CCUSD Elementary schools. In order to register for morning care, you must pay a non-refundable \$50.00 Registration Fee. Morning care is open from 7:00a.m. to 8:45a.m. The fee is \$100.00 per month. When morning care is combined with after-school care, the morning care fee is discounted to \$80.00 per month. If you choose to add morning care, please add \$80.00 to your monthly after school fees.

After School Programs ~ School Age Only

In order to register and secure a space in the <u>After School Program</u>, you must pay a non-refundable \$50.00 Registration Fee. If you are enrolling your child <u>AFTER</u> August, you will have to pay the <u>first month's tuition</u> plus the Registration Fee. *If you are enrolling in both morning and aftercare, only one \$50.00 enrollment fee is needed.*

Frequently Asked Questions

When can I register my child?

You can submit an application to the Office of Child Development as of January, 2019.

How will my child be selected?

It will be on a first come first serve basis. However, we do give priority to siblings.

How will I be notified if my child was accepted?

You will be notified by a phone call.

Can I call to find out if my child was accepted?

You can call or email Jessica at <u>Jessicahurston@ccusd.org</u> for a status update but you will not get an answer until we have finished enrolling families.

Does my child have to attend elementary school in order to be eligible?

No, your child does not need to be enrolled in order to receive to complete a waiting list application.

What happens if I transfer my child to another school? Will I get to transfer my child's care?

No, you cannot transfer your child's care, as we have allotted amount of spaces for care and enroll based number of spaces. Checking to see if we have space available before accepting a transfer is highly recommended.
