## **Assessment of the Current Status of School Crime**

A review of our school indicates that the students, parents, and staff of Cornerstone are safe on campus, off campus at school-sponsored events, and traveling directly to and from school.

Visitors on campus are to check in at the office with the Raptor system. They receive a photo ID badge which they must wear while on campus. Upon leaving, they return the badge and sign out.

During the 2018-2019 school year, there was one suspension reported at Cornerstone. There were no instances of hate crime. In the 2019-2020 school year, there have been no suspensions nor expulsions to date.

Cornerstone Elementary creates a safe school environment. The school implements programs and practices to address bullying that are aligned to District policy (reference Board Policy 5131.2).

In addition, social-emotional learning (2<sup>nd</sup> Step Curriculum), bully prevention, Positive Behavior Intervention Strategies (PBIS) and character development are addressed at monthly school assemblies, weekly morning messages, grade level events, and via e-mail to parents. Cornerstone believes that these issues should be a priority and they are addressed year-round in order to promote positive and inclusive behavior.

Parents attend classroom in-services, general parent meetings and parent education nights to stay informed about the programs at Cornerstone. The opportunities to be involved and to make a difference in a child's education are abundant at the school.

PVPUSD utilizes Aeries reporting to track our student attendance and monitor concerns with chronic absenteeism. There is a process for sites to follow when there is a concern regarding absenteeism and truancy. All schools have a School Attendance Review Team (SART) to collaborate and consult on how to provide intervention to the students and families with identified attendance issues. The District also holds Student Attendance Review Board (SARB) hearings for cases that are not resolved at the site level and need further intervention.

Alternate means of correction are employed to address discipline infractions prior to suspension for lower level Education Code violations. As a preventative measure, all K-8 schools have implemented Positive Behavior Intervention Supports (PBIS), which focuses on teaching our students about behavioral expectations and providing positive feedback. Restorative practices are being utilized across the district to ensure a comprehensive approach to discipline and behavior interventions.

PVPUSD has a comprehensive approach to student mental health and support across our K-12 schools to address the identified needs in our California Healthy Kids Survey. Our district has a well-developed suicide prevention policy that encompasses education, intervention and postvention programs. All certificated and classified staff have been trained in suicide prevention education. Students in grades 7-12 are also receive classroom guidance lessons focused on mental health, social-emotional supports and suicide prevention. Our K-8 schools have also implemented Social Emotional Learning curriculum as preventative education. There has been an increase in the days the school psychologist has been assigned to each elementary school site with a focus on supporting the social-emotional needs of general education students.

# **Child Abuse Reporting Procedures**

Mandated reporters include, but are not limited to, teachers; instructional aides; teacher's aides or assistants; classified employees; certificated pupil personnel employees; administrative officers or supervisors of child attendance; administrators and employees of a licensed day care facility; Head Start teachers; district police or security officers; licensed nurses or health care providers; and administrators, presenters, and counselors of a child abuse prevention program. (Penal Code 11165.7)

Reasonable suspicion means that it is objectively reasonable for a person to entertain a suspicion, based upon facts that could cause a reasonable person in a like position, drawing when appropriate on his/her training and experience, to suspect child abuse or neglect. However, reasonable suspicion does not require certainty that child abuse or neglect has occurred nor does it require a specific medical indication of child abuse or neglect. (Penal Code 11166)

## **Reportable Offenses**

A mandated reporter shall make a report using the procedures provided below whenever, in his/her professional capacity or within the scope of his/her employment, he/she has knowledge of or observes a child whom the mandated reporter knows or reasonably suspects has been the victim of child abuse or neglect. (Penal Code 11166)

## **Responsibility for Reporting**

The reporting duties of mandated reporters are individual and cannot be delegated to another person. (Penal Code 11166)

No supervisor or administrator shall impede or inhibit a mandated reporter from making a report. (Penal Code 11166)

## **Reporting Procedures**

### **1. Initial Telephone Report**

Immediately or as soon as practicable after knowing or observing suspected child abuse or neglect, a mandated reporter shall make an initial report by telephone to any police department (excluding a school district police/security department), sheriff's department, county probation department if designated by the county to receive such reports, or county welfare department. (Penal Code 11165.9, 11166)

### **2. Written Report**

Within 36 hours of knowing or observing the information concerning the incident, the mandated reporter shall then prepare and either send, fax, or electronically

submit to the appropriate agency a written follow-up report, which includes a completed Department of Justice form (SS 8572). (Penal Code 11166, 11168)

#### Victim Interviews by Social Services/Law Enforcement

Whenever a representative from the Department of Social Services or another government agency investigating suspected child abuse or neglect deems it necessary, a suspected victim may be interviewed during school hours, on school premises, concerning a report of suspected child abuse or neglect that occurred within the child's home or out-of-home care facility. The child shall be given the choice of being interviewed in private or in the presence of any adult school employee or volunteer aide selected by the child. (Penal Code 11174.3)

A staff member or volunteer aide selected by a child may decline to be present at the interview. If the selected person accepts, the principal or designee shall inform him/her of the following requirements: (Penal Code 11174.3)

1. The purpose of the selected person's presence at the interview is to lend support to the child and enable him/her to be as comfortable as possible.
2. The selected person shall not participate in the interview.
3. The selected person shall not discuss the facts or circumstances of the case with the child.
4. The selected person is subject to the confidentiality requirements of the Child Abuse and Neglect Reporting Act, a violation of which is punishable as specified in Penal Code 11167.5.

If a staff member agrees to be present, the interview shall be held at a time during school hours when it does not involve an expense to the school. (Penal Code 11174.3)

#### Release of Child to Peace Officer

When a child is released to a peace officer and taken into custody as a victim of suspected child abuse or neglect, the Superintendent or designee and/or principal shall not notify the parent/guardian, but rather shall provide the peace officer with the address and telephone number of the child's parent/guardian. It is the responsibility of the peace officer or agent to notify the parent/guardian of the situation. (Education Code 48906)

The investigating agency is required under Penal Code Section 11169 to submit to DOJ a Child Abuse Investigation Report Form SS 8583 if (1) an active investigation was conducted and (2) the incident was not determined to be unfounded.

## DEFINITIONS AND GENERAL INSTRUCTIONS FOR COMPLETION OF FORM SS 8572

All Penal Code (PC) references are located in Article 2.5 of the PC. This article is known as the Child Abuse and Neglect Reporting Act, also known as CANRA. The Internet site is: <http://www.leginfo.ca.gov/calaw.html> (specify Penal Code and search for Sections 11164-11174.3). A mandated reporter must complete and submit the form SS 8572 even if some information is not known. (PC Section 11167(a).)

### I. MANDATED CHILD ABUSE REPORTERS

- Mandated child abuse reporters include all those individuals and entities as defined in PC Section 11165.7.

### II. TO WHOM REPORTS ARE TO BE MADE (DESIGNATED AGENCIES)

- Reports of suspected child abuse or neglect shall be made by mandated reporters to any police department or sheriff's department (not including a school district police or security department), county probation department (if designated by the county to receive mandated reports) or the county welfare department. (PC Section 11165.9.)

### III. REPORTING RESPONSIBILITIES

- Any mandated reporter who has knowledge of or observes a child, in his or her professional capacity or within the scope of his or her employment, whom he or she knows or reasonably suspects has been the victim of child abuse or neglect shall report such suspected instance of abuse or neglect to a designated agency immediately or as soon as practically possible by telephone and shall prepare and send a written report thereof *within 36 hours* of receiving the information concerning the incident. (PC Section 11166(a).)
- No mandated reporter who reports a suspected instance of child abuse or neglect shall be held civilly or criminally liable for any report required or authorized by the CANRA. Any other person reporting a known or suspected instance of child abuse or neglect shall not incur civil or criminal liability as a result of any report authorized by the CANRA unless it can be proven the report was false and the person knew it was false or make the report with reckless disregard of its truth or falsity. (PC Section 11172(a).)

### IV. INSTRUCTIONS

- SECTION A - REPORTING PARTY:** Enter the mandated reporter's name, title, category (from PC Section 11165.7), business (agency) name and address, telephone number, a signature and today's date. Also check yes-no whether you (the mandated reporter) witnessed the incident. The signature area is for either the mandated report or the person taking as telephoned report.

### IV. INSTRUCTIONS (Continued)

- SECTION B - REPORT NOTIFICATION:** Complete the name and address of the designated agency notified, date of the written report, date/time of the phone call and the name, title and telephone number of the official contacted.
  - SECTION C - VICTIM** (One Report per Family, siblings must have same parents/guardians): Enter the victim's name, address, telephone number, birth date or approximate age, sex, ethnicity, present location, and where applicable enter the school, class (indicate the teacher's name or room number), and grade. List the primary language spoken in the victim's home. Check the appropriate yes-no box for: developmentally disabled?, physically disabled? and specify the victim's other disability. To determine if the victim has a disability, ask the victim's parent or care giver. Also check the appropriate yes-no box for in foster care?, indicate type of care if the victim was in out-of-home care, indicate the type of abuse. List the victim's relationship to the suspect, check the appropriate yes-no box for photos taken?, indicate whether the incident resulted in this victim's death.
  - SECTION D - INVOLVED PARTIES:** Enter the requested information for: Victim's Siblings, Victim's Parents/Guardians and the Suspect.
  - SECTION E - INCIDENT INFORMATION:** If multiple victims, enter the number. Enter date/time and place of the incident. Provide a narrative of the incident. Attach extra sheets if needed.
- ### V. DISTRIBUTION
- Reporting Party:** After completing Form SS 8572, retain the yellow copy for your records and submit the top three copies to the designated agency.
  - Designated Agency:** *Within 36 hours* of receipt of Form SS 8572, send **white copy** to police or sheriff, **blue copy** to county welfare or probation, and **green copy** to district attorney.

## **Disaster Response Procedures**

Cornerstone at Pedregal Elementary School has developed an Emergency Disaster Preparedness Plan using the Standard Emergency Management System (SEMS) and in compliance with NIMS that defines procedures to be followed in the event of an emergency.

The plan includes site-specific, detailed instructions for action in the event of an occurrence such as a bomb threat, an earthquake, the threat of explosion, hazardous material on campus, intruder on campus, or gunfire in the vicinity of the school. The plan delineates the responsibilities of individual employees. Special Assignment Teams are described and have been organized and trained in advance for such roles as Student Supervision, Campus Search and Rescue, and First Aid.

We conduct two complete earthquake drills each year to make sure that in an emergency situation, our school will follow the emergency plan to make students and staff as safe and comfortable as possible during the event of a true emergency situation. We conduct a minimum of one evacuation drill a year where all students and adults on campus must evacuate the campus. We also do monthly drop drills in the classrooms and monthly fire drills. Every classroom has a walkie-talkie and we have drills to ensure walkie-talkies are turned on and working properly.

Our Parent Board/PTA annually takes inventory of the two disaster sheds on campus making sure that we have sufficient food, water, and supplies for at least three days. We continue to purchase additional cots, supplies, and easy-ups each year.

In the case of a fire, our school can be evacuated to safety within four minutes. We regularly practice drills. In case of flooding or any additional disaster, the procedures are explained in the emergency plan. The staff knows to listen for the fire bell followed by verbal directions indicating the nature of the emergency.

Cornerstone has outstanding procedures in place in the event of a natural disaster or emergency. Cornerstone staff underwent an American Heart Association training to learn hands free CPR and we also had a refresher lesson on triage and search and rescue and “stop the bleed.”

All district faculty and staff have received active shooter training called Run- Hide-Fight.

All District school sites have implemented a Visitor Management System called Raptor, to increase safety and security measures on campus. The Raptor Visitor Management school security system screens for sex offenders, alerts staff of custody violations, and provides districtwide reporting for all visitors.

All District school sites and offices have at least one Automatic External Defibrillator (AED) on campus.

All District school sites have a tactical response plan in place. Special consideration has been given to emergency procedures with regard to students with disabilities.

The District works collaboratively with local fire, police, sheriff, and EMS (LA County and Palos Verdes Estates) to ensure the safety of staff and students.

## Procedures for Notifying Teachers about Dangerous Pupil

In order to fulfill the requirements made by Education Code 49079 and Welfare and Institutions Code 827 that state teachers must be notified of the reason(s) a student has been suspended. The Palos Verdes Peninsula Unified School District has incorporated this notification into the existing "Attendance Reporting screen". On the daily attendance report, when a student is suspended, will show an "SSA" next to the student's name. The teacher can access the suspension by looking at the student's discipline screen. The information provided is for the student's current teachers only. All information regarding suspension and expulsion is **CONFIDENTIAL**, is not to be shared with any student(s) or parent(s). Teachers are asked to secure the list so students and others may not view it.

Pursuant to Welfare & Institution Code 827(b) and Education Code 48267, the Court notifies the Superintendent of the Palos Verdes Peninsula Unified School District regarding students who have engaged in certain criminal conduct. This information is forwarded to the site Principal. The site Principal is responsible for prompt notification of the student's teachers. Per Education Code 49079, this information must be kept confidential. This information is also forwarded to all administrators and the student's counselor.

## **Procedures for Safe Ingress and Egress from School**

Cornerstone at Pedregal Elementary School is proud to be part of a school district with a mission to provide a safe environment for all children, parents, and all school employees. Cornerstone works closely with the Lomita Sheriff's Station and the City of Rancho Palos Verdes to guarantee that the school's surrounding community is safe. Parent volunteers are assigned to monitor and supervise the play areas before school, at recess, and at lunch. Cornerstone staff members supervise the lunch area and make sure that the environment is clean and safe for all students. Parent volunteers and Cornerstone staff are regularly scheduled to help with the unloading and loading of students in the parking lot located in the front of the school. There is also parent volunteer and staff supervision by the HYTE Street exit for grades 4 and 5. Parents are trained at in-service trainings and general parent meetings on the safety guidelines and traffic patterns of the school. All parent volunteers provide evidence of a current TB test. In addition, the school principal helps with the safe arrival and departure of students at Cornerstone Elementary.

All staff and teachers are trained (child abuse reporting responsibilities, infectious disease procedures, disaster plan responsibilities and procedures, confidentiality rules, conflict mediation procedures, student discipline strategies) and provide evidence of current TB test or TB Risk Assessment Waiver.


To ensure the safety of bike riders, students in grades 3-5 may ride bikes to school as long as they follow the safety guidelines of wearing a helmet, following the safety rules for bike riding, and walking the bike on the school campus.

Additional School District programs such as PVPUSD Kids' Corner (on campus child care) and enrichment programs provide safe activities for students to participate in both before and after school.

Cornerstone at Pedregal Elementary is proud of the excellent working relationship with the city of Rancho Palos Verdes and the local police officers. Police officers often help reinforce that the people driving in the neighborhood keep safety as a top priority at all times. Police officers are also visible in the community as they frequently patrol the neighborhood and check on the school's safety.

School district programs such as PV Kids' Corner (a child care program located on campus) and an enrichment program, provide safe activities for students to participate in both before and after school.
