Cosmetology Program Syllabus 2018 - 2019 Mrs. Nicole Shearer

Program Overview

Would you enjoy being a Hair Stylist, Nail Technician, Skin Care Technician, Salon Owner, or Platform Artist? Students learn the latest techniques in the care and treatment of hair, skin and nails. The students will practice and perfect skills on mannequins, then advance to performing these services on clients in the school salon. A state license is required in all of these areas. A minimum of 1250 hours is required to qualify for Cosmetology licensing. Incorporating academic skills as well as people skills with a strong focus on safety and State Law is a requirement. This program focuses on being competent in entry level skills within the profession. Participation and preparedness in extra curriculum activities such as field trips, clubs, job shadowing and the like are of focus. This course includes business practices such as math, reading and science.

Instructional Philosophy

Students will be actively engaged in learning the content of this course through hands-on activities such as job shadowing, projects, problem solving activities and live salon work. Technology will be used in finding information about the industry. Students will use modern equipment, products and techniques cooperatively and independently to master skills. Computer skills will be used to create resumes, cover letters and thank you letters and in developing a professional portfolio and advertising images. Outside professional guests will be invited to share real salon policies, procedures and expectations. Daily grades, test grades and projects will determine their level of success. Analyzing and determining procedures to be used in various circumstances is required. Productivity determines the level of success. Characteristics of a healthy, positive attitude must be displayed at all times.

Students will be given challenging real-world projects and assignments typical of the cosmetology field. High quality work is expected and students will be given opportunities to redo work until it meets standards. Classroom activities will include reading, research, projects, and problem solving and laboratory activities. Major projects may be presented to the class. Students will often work in teams, but will be expected to complete individual assignments in relation to the team's work.

If necessary, students will be given more than one opportunity to complete assignments to meet Course standards.

Course Goals

- All unit chapters will be completed to at least 85% or higher
- All ethnic hair types will be addressed
- Research and development of business plans
- Explain procedures required to solve hair/nail/skin needs
- Select the necessary tools and products needed to perform services
- Research cost and margin of profit necessary to cover business success
- Manage the daily operation of a successful business
- Reproduce techniques studied in theory to real live guest services
- Select products based on individual needs
- Monitor and develop a plan for increasing repeat visits
- Critique retail sales and develop a plan to increase sales
- Conduct services in the prescribed time.
- Advanced status on National Occupational Competency Test given in the senior year

Major Assignments and Assessments

- Develop a marketing plan for your salon select a logo, slogan, menu of services you will offer and the pricing structure
- Write a research paper
- Create a print advertisement

Assessment and Grading Plan

- Professionalism will be evaluated with a daily grade for attendance, image, preparation and participation, courtesy, following directions, and safety guidelines
- Advanced proficiency with the National Occupational Competency Test written and performance
- State Board Examination License

NOCTI Assessment

All eligible seniors completing the program are required by the state of Pennsylvania to take a National Occupational Competency Testing Institute (NOCTI) exam related to their program or study. NOCTI provides occupational competency assessments required by the PA Department of Education (PDE) to measure and evaluate a student's competency in their technical program. Students must take both the written and performance sections. This test will be used as a cumulative final exam grade of 10% for seniors.

Methods of Evaluation

The assignments and assessments for this course will be graded using a weighted system of measurement. Students will be evaluated on the following items and will constitute their final quarter grade:

- Tests (30%)
- Daily Grade (Attendance, Participation, Professionalism) (40%)
- Tasks and Projects (30%)
- (Seniors) NOCTI Test and portfolio-20% of final grade*
 *for eligible seniors only
- (Juniors and Sophomores) Career Readiness Grade level requirements-20% of final grade
