 - In the winter at Parent-Teacher Conferences (held during a one day period – day and evening hours available)
 - Whenever a parent requests a conference with a teacher or vice versa
3. Provide parents with frequent reports on their child's progress. Specifically, the school will provide reports as follows:
 - At the end of each grading period (report cards)
 - PSSA results when received from the state
 - Mid-term Progress Reports sent home

 - At the annual Title I meetings, the committee members will aid in the development, implementation, and evaluation of the school's Title I schoolwide program.
