**PLEASE TAKE NOTICE** that Richard Kipperman, as Receiver (the "Receiver") duly appointed in the matter of *People of the State of California v. McManus*, Case. No. SCD266439 (the "Case"), pending in the Superior Court of the State of California for the County of San Diego (the "Court"), exercising authority granted pursuant to the permanent Order entered July 15, 2019, by the Court in the Case, has elected to close the charter school known as California Prep Sutter 8-12, CDS # 51-71415-0132761 (the "School") effective immediately.
