FEDERAL FISCAL COMPLIANCE</p> <p>The Board shall review and approve all applications for federal funds submitted by the district.</p> <p>The Board designates the Superintendent or designee as the district contact for all federal programs and funding.</p> <p>The Superintendent or designee shall develop administrative regulations governing the procurement, use, management and disposal of goods, materials and equipment purchased with federal grant funds. At a minimum, the administrative regulations shall provide procedures to ensure:</p> <ol style="list-style-type: none"> <li>1. Expenditures of federal grant funds are completed in accordance with federal requirements.</li> <li>2. Title to and control of location, custody and security of equipment and/or property purchased with federal funds are maintained.</li> </ol> <p>The Business Manager shall track and document all federal programs expenditures and verify budgetary information required for those programs.</p> <p>All district employees paid with federal funds shall document the time they expend towards federal programs, in accordance with law.</p> <p>References:</p> <p>No Child Left Behind Act – 20 U.S.C.
