I understand that if a test of my child's specimen reveals an unexplained presence of a drug, the District may take action against my child up to and including termination of participation in extracurricular activities or parking privileges.

## **STUDENT PARKING RULES AND REGULATIONS 2018-2019**

Student parking is a *privilege* that may be suspended or revoked for failure to follow rules and regulations. Please read the following guidelines for parking at Magnolia High School.

1. Students must have a valid Magnolia Parking Tag in order to park on school grounds.
2. The following documentation is required in order to obtain and to continue to hold a parking permit.
  - a. A valid Texas Driver's License. (copy required)
  - b. Proof of insurance with the vehicle information for which the permit is obtained. The student's name **must** appear on the policy. (copy required)
  - c. Make, Model, and license plate number of vehicle.
  - d. Completed Parking Permit Form signed by student **and** parent/guardian.
  - e. Maintain participation in Magnolia ISD Mandatory Drug Testing Program with signed Testing Consent Form.
  - f. A check or cash in the amount of \$50.00, \$75.00, or \$100.00 for the appropriate parking space fee. Make checks payable to Magnolia High School.
3. Student parking privileges may be suspended or revoked for any of the following:
  - a. Excessive absences or tardies.
    - 3 or more tardies or absences to 1<sup>st</sup> period may result in disciplinary action by administration.
    - Excessive and repeated absences and/or tardies may result in loss of parking privileges.
    - Parking fees will not be reimbursed if parking privileges are revoked due to discipline.

- b. Parking in a lot not designated for students.
  - c. Parking a car that is not registered.
  - d. Parking in handicapped or unauthorized areas.
  - e. Reckless Driving.
  - f. Damaging someone else's vehicle.
  - g. Failure to follow directives by security.
  - h. Parking in a fire zone area or on the grass.
  - i. Leaving the building to go to the parking lot without permission.
  - j. Littering
  - k. Loitering in parking lot before, during, or after school.
  - l. Invalid or expired insurance or driver's license.
  - m. Failure to participate in mandatory drug test program.
  - n. Drug testing results violate Magnolia ISD Board Policy FNF(Local).
4. Parking tags must be placed on the rear view mirror, facing outward. Anyone that parks illegally or without proper permission on school property is subject to having their vehicle towed at the owner's expense.
5. The school is not responsible for stolen items or vehicle damage on school property. However, we will assist you with these matters whenever possible.
6. Be aware that canine units routinely patrol the parking areas.
