The Bibb County Board of Education met in a Called Session on May 18, 2018, at 10:00 a.m. in the Central Office. The Invocation was given by Mrs. Dailey followed by the Pledge of Allegiance led by Mr. Moody. Roll Call was conducted by Board Vice President, Mr. Mike McMillan:

Mrs. Dailey made a motion to approve the agenda. Mr. Moody seconded the motion which passed unanimously.

Mrs. Jones made a motion to approve early release of students on May 23 and May 24, 2018. Mrs. Moody seconded the motion which passed unanimously.

Mrs. Dailey made a motion to approve the Assistant CSFO Job Description and Pay Scale, received on May 8, 2018. Mrs. Jones seconded the motion which passed unanimously.

Mr. Moody made a motion to approve Bid for Replacement Dugouts at West Blocton High School to (only bidder) Snow-Blakeney Construction, Inc. for the amount of \$46,115.00. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Jones made a motion to approve Shelley Jones to work up to ten additional days, at regular rate of pay, this summer to provide speech language services. Payment will be made from IDEA Funds. Mrs. Dailey seconded the motion which passed unanimously.

Mr. Moody made a motion to approve Amy Hatter to work up to five additional days, at regular rate of pay, over the summer reviewing and writing IEP's. Payment will be made from IDEA Funds. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Dailey made a motion to approve Katie Crumpler to provide OT summer services for an additional 6 half days, at regular rate of pay. Payment will be made from IDEA Funds. Mrs. Jones seconded the motion which passed unanimously.

Mr. Moody made a motion to approve payment to Roger Smitherman to paint hallways, office, and library during the summer. Payment of \$6,275 will be paid from West Blocton Elementary general fund and PTO funds. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Jones made a motion to approve stipend to 13 Teachers attending the Summer Data meeting. Stipend of \$100 per member in attendance will be paid from West Blocton Middle School Title 1 funds. Mrs. Dailey seconded the motion which passed unanimously.

Mr. Moody made a motion to approve payment to Janet Taylor to conduct a Summer Technology session. Payment of \$1,000.00 will be paid from West Blocton Middle School Title 1 funds. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Dailey made a motion to approve payment of stipend to teachers attending Champions of Classroom Communities Classroom Management Workshop, June 28, 2018. Payment of \$60 for attendance of half day training, if not using the FLEX day option, will be made from Title I or II funds. Mrs. Jones seconded the motion which passed unanimously.

Mrs. Jones made a motion to approve payment of Jennifer Turner as facilitator for 3rd Grade Saxon Phonics Training, July 2018. Payment of \$125 will be made from Title I or II funds. Mr. Moody seconded the motion which passed unanimously.

Mrs. Dailey made a motion to approve payment of stipend to teachers attending 3rd Grade Saxon Phonics Training, July, 2018. Payment of \$60 for attendance of half day training, if not using the FLEX day option, will be made from Title I or II funds. Mrs. Jones seconded the motion which passed unanimously.

Mr. Moody made a motion to approve payment of stipend to attendees of Library Media Specialists Workshop, June 4, 2018. Payment of \$100 for attendance of full day training, if not using the FLEX day option, will be made from Title I or II funds. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Jones made a motion to approve payment of stipend to lead teachers attending Collaborative Classroom Literacy Workshop, May 31, 2018. Payment of \$100 for attendance of full day of training, if not using the FLEX day option, will be made from Title I or II funds. Mrs. Dailey seconded the motion which passed unanimously.

Mr. Moody made a motion to go into Executive Session- Student. Mrs. Dailey seconded the motion which passed unanimously.

Mr. Moody made a motion to return to Regular Session. Mrs. Jones seconded the motion which passed unanimously.

Mrs. Jones made a motion to expel student V.H. for the remainder of the 2017-18 school year. Student is to reenroll in West Blocton Middle School for 2018-19 school year and will be placed at Alternative School from August 7, 2018- August 31, 2018. Student will return to WBMS Sept 4, 2018. Mrs. Dailey seconded the motion which passed unanimously.

Mrs. Dailey made a motion to accept and approve the resignation/retirement of Ginger Smith, Preschool Teacher. Effective June 1, 2018. Mrs. Jones seconded the motion which passed unanimously.

Mrs. Jones made a motion to accept and approve the resignation/retirement of Emily Blake, Librarian, Brent Elementary School. Effective June 1, 2018. Mrs. Dailey seconded the motion which passed unanimously.

Mr. Moody made a motion to approve Brent Elementary in school transfer for the 2018-19 school year for the following:

Mrs. Jones seconded the motion which passed unanimously.
