**Q:** The Food Products item list #0000806 Mayonnaise specifies Diamond Crystal #70812. This particular item is no longer available and the manufacturer is now offering a reformulated version of the item as #70811. This reformulated item was submitted to your office in December. Is this new Diamond Crystal #70811 an approved substitute for the listed #70812?

**A:** Yes, Diamond Crystal #70811 is an acceptable replacement for #70812.

Please note that the Paper & Cleaning Products bid originally included with the main bid (all sections) was set aside due to a defect in the process that was discovered prior to evaluations of any of the submitted bids.
