Foreward

Durango School District 9-R believes that participation in athletics and activities helps our students achieve academic excellence. Our athletics/activities program is aligned with CHSAA and is an integral part of our students' education. Students who participate in athletic and activity programs have better school attendance, fewer disciplinary problems and higher graduation rates. The Durango School District 9-R takes great pride in the efforts and accomplishments of all our participants!

Philosophy

The Durango School District 9-R views Student Athletics and Activities as an extension of the classroom and an integral part of a student's overall educational experience. Students are encouraged to participate in a variety of clubs, organizations, and activities. Students selected for the privilege of membership in athletics and activities represent their school, and their behavior is expected to reflect positively on their school and community.

Participation in athletics and activities should be:

- Enjoyable to participants and spectators/fans/audiences;
- Educational in both academic pursuits and citizenship;
- Ethical, practicing values of respect, responsibility, and perseverance.

Academic Eligibility

A participant will become ineligible if they have one or more failing grades.

A participant will not be allowed to miss school for a contest if they have a D grade.

Attendance

Attendance is crucial to success in school and student athletes are expected to attend school regularly. Student-athletes who's attendance becomes under review may be subject to loss of privilege of participation.

Athletes must be present ½ day to participate in any contest that day. If a contest falls on a non school day, this rule applies to the previous school day.

Citizenship & Sportsmanship

All participants are expected to exhibit sportsmanship and courteous conduct towards all coaches, officials and opponents as hosts and guests.

During competitions, any disqualification from a contest for committing an unsportsmanlike act will result in being ineligible for the next contest.

Participants are expected to reflect positively on their school and program by following all school and team rules and procedures.

While on road trips participants will remain in gym or facility with their team and coaches and will not leave the area without school supervision.

General Conduct

Bullying, Hazing and Harassment

Durango School District is committed to a safe and civil educational environment for all students, employees, volunteers and patrons free from harassment, intimidation, bullying, cyber-bullying, sexual harassment, sexting or hazing. Incidents relating to such will be reviewed and consequences determined by school administration.

Controlled Substances

Policy on Tobacco, Alcohol, Drugs and Paraphernalia

A student/athlete will not possess, use, distribute, or be under the influence of any controlled substance or possess paraphernalia including vape devices. A controlled substance includes but is not limited to alcohol, narcotics, tobacco, inhalants, hallucinogenic drugs, amphetamines, barbiturate, marijuana, or any intoxicant of any kind.

Violations

All violations relating to controlled substances will be reviewed and consequences determined by administration.

Other unacceptable behavior and/or conduct detrimental to self, team or school, not defined above is subject to disciplinary actions via administration.

Ineligible Athletes

Athletes who are ineligible for any of the above reasons should attend practice unless excused by coaches and parents but may not play, suit up or travel with the team.

Concussion Protocol

Athletes diagnosed with a concussion must follow 9R concussion protocol and cannot return to play without clearance from a physician and certified athletic trainer.

Transportation

Participants are expected to use school transportation to all activities. On away events participants may only ride home with their parents/guardians unless a Transportation Consent and Release Form is filled out and on file in the school office beforehand.

Parents/guardians must sign out their athlete with a coach when picking them up from an away location.

Fees

Durango 9R charges athletic fees to help offset costs associated with participation. Students who are eligible for the Free and Reduced Lunch Program will have their fees waived.
