SUPPLEMENTAL INSTRUCTIONS FOR CAREGIVER'S AUTHORIZATION AFFIDAVIT

The purpose of this Affidavit is to register students who are living with or without a parent in the home of another relative, and whose parents cannot otherwise prove residency.

This affidavit is not valid for more than one year after the date on which it is executed.

"Qualified relative" for purposes of Item 5 means a spouse, parent, stepparent, brother, sister, stepbrother, stepsister, half-brother, half-sister, uncle, aunt, niece, nephew, first cousin or any person denoted by the prefix "grand" or "great", or the spouse of any of the persons specified in this definition, even after the marriage has been terminated by death or dissolution.

The law may require you, if you are not a relative or a currently licensed foster parent, to obtain a foster home license in order to care for a minor. If you have any questions, please contact your local department of social services.

If the minor stops living with you, you are required to notify any school, health care provider, or health care service plan to which you have given this affidavit.

If you do not have the information requested in Item 8 (California Driver's License or ID), provide another form of identification such as your social security number or Medi-Cal number.

Section 48204 of the Education Code provides that this affidavit constitutes a sufficient basis for determination of residency of the minor, without the requirement of a guardianship or other custody order, **unless the District determines from actual facts that the minor is not living with the caregiver.**

The District will require the following documentation that the caregiver lives at the address provided in Item 4.

Current original utility bills from **two** different sources (must show service address and residence address as one and the same), **and one of following:**

Homeowners - sales contract, grant deed, or current tax bill (must show mailing and residence address as one and the same).

Renters - Rental agreement, name, address, phone number of manager, landlord.
