WHAT: New York State Driver Education Course. 24 hours of classroom instruction and 24 hours of road instruction. MV-285 awarded upon successful completion of the course. No school credit toward graduation is awarded.

WHEN: All students need to report on **Monday, February 4th!**

WHO: Le Roy Central school residents who are 16 years old before the start of the class.

WHERE: Le Roy Jr.-Sr. High School **ROOM 355 (MR. BATTAGLIA)**

FEE: \$300.00 The entire \$300* must accompany your registration form. No cash, only checks or money orders payable to Le Roy Central School District. *The District reserves the right to make alternate arrangements for families as deemed necessary.

REGISTRATION:

Complete registration form and return with full payment to the Le Roy High School office by **Tuesday, January 29th, 2018.** Failure to return by this date may result in you not having a spot in the class.

ROAD SCHEDULE: Will be assigned during class time.

OVER ENROLLMENT:

In the event of over registration, the priorities listed below will be followed. 1. Seniors without licenses. 2. Juniors without licenses. 3. Seniors with licenses. 4. Juniors with licenses. 5. Others in descending order of date of birth.

SCHEDULING:

- The Le Roy Central School district reserves the right to cancel class and drive sections.
- If a student misses more than one car session, you will be charged an additional \$25 for each missed session.
- The replacement cost for a driver education certificate is \$10.
- A late arrival to a classroom session will result in an additional drive time. 3 or more late arrivals will immediately result in the removal from the course without reimbursement.
- 3 or more unexcused absences from classroom sessions will immediately result in the removal from the course without reimbursement.
- Drive times will leave from the Athletic Entrance at the exact time in which they are scheduled.
