2. *Parent Survey Overview*-We looked at the data and the different categories. We can see that approximately 80 % of comments were positive. Most parents prefer their child to not wear uniform. Safety is one concern, regarding drop off and pick up in front of the school, but we are working on it with the proper officials to ensure safety.
3. *CAASPP Overview*-Multi-Year Cohort Comparison-
Looked at data- we went up approximately 3% from last year- ELA
Principal Vandenberg explained that we go over this data at our data reflection sessions, with our grade levels, to discuss how to meet the needs of our students based on the results.
With Math, we noted that students are still working on explaining their reasoning with their written responses. Regarding our subgroups, 52% are meeting standards or above. This data helps us look at how each category of students are performing-(students with disabilities, EL'S, and our Socio-Economic groups).
