Dear Inglewood Unified School District Families and School Community,

The health and safety of our students and staff are paramount to Inglewood Unified School District (IUSD). After long and careful deliberation, in a proactive effort to protect the health of our students and staff, the Inglewood Unified School District will close our campuses, including the Child Development Center and Adult School, to students beginning on Monday, March 16, 2020, for the next two weeks until further notice. We will begin to provide instruction remotely.

Our employees have been preparing for the possibility of school closures. We are committed to providing instruction that will allow us to maintain continuity of learning. Your child's school principal and teachers will be in touch with you to inform you of the details of these plans. While we recognize that there is no way for remote instruction to fully replace daily face-to-face classroom instruction, it will allow our students to access their curriculum, practice skills, and have some structure to their day. Our teachers will be working to provide valuable educational experiences. We appreciate their dedication and creativity in this effort.

During this time, all school activities, including those scheduled on-campus and off-campus (e.g., field trips, sporting events), have been cancelled. Activities include but are not limited to the following: school-based programs and events, sports programs, parent meetings, dual-enrollment classes or public gatherings.

We understand that this move to remote instruction will be challenging for many families. We appreciate your flexibility as we work to implement the measures that we feel are necessary to protect the health of our entire community. **We appreciate your patience and understanding during this difficult time. We ask parents and students to be mindful of the guidance to avoid activities involving large gatherings.**

Inglewood Unified will be sharing more information regarding instructional support, meal services, and other procedures.
