Student Parking Guidelines/Rules & Regulations

1. STUDENTS SHOULD **NOT** TRANSPORT OTHER STUDENTS WITHOUT PERMISSION FROM THE SCHOOL PRINCIPAL. 1ST OFFENSE: 9-week suspension of on-campus driving/parking privileges. 2ND OFFENSE: 1-year suspension of on-campus driving/parking privileges.
2. STUDENTS ARE NOT PERMITTED TO RETURN TO THEIR VEHICLES FOR ANY REASON.

3. STUDENTS ARE NOT PERMITTED TO LOITER ON CAMPUS OR IN THE PARKING LOT.
4. VEHICLES MUST BE OPERATED IN ACCORDANCE WITH GEORGIA STATE LAW, BARTOW COUNTY SCHOOL BOARD POLICIES, AND BARTOW COUNTY COLLEGE RULES WHILE ON CAMPUS.
5. DECALS MUST BE AFFIXED TO THE DRIVE'S SIDE LOWER PART OF THE WINDSHIELD WHERE VISIBLE.
6. STUDENTS WILL PARK IN DESIGNATED PARKING AREAS ONLY.
7. VEHICLES ARE SUBJECT TO SEARCH BY SCHOOL PERSONNEL AND DECAL HOLDERS ARE RESPONSIBLE FOR CONTENTS IN VEHICLE.
8. DISCIPLINE REFERRALS, ATTENDANCE AND TARDIES TO CLASS OR ANY OTHER SERIOUS SCHOOL RULE INFRACTION WILL BE CAUSE FOR YOUR PARKING PRIVILEGES TO BE SUSPENDED. AFTER FIVE (5) TARDIES YOUR PARKING WILL BE SUSPENDED UNTIL YOU HAVE BEEN TARDY FREE FOR TEN (10) CONSECUTIVE SCHOOL DAYS.
9. SCHOOL IS NOT RESPONSIBLE FOR THEFTS OR DAMAGE TO VEHICLES.
10. THE STATE DEPARTMENT OF MOTOR VEHICLES WILL BE NOTIFIED WHEN A STUDENT EXHIBITS A PATTERN OF NON-ATTENDANCE.
