### SENIOR GRADUATION CONTRACT

A senior's graduation from high school is a transition into adulthood requiring adult demeanor. Seniors are the role models on campus and should conduct themselves responsibly. Commencement, Grad Night, and dances are dignified activities enhanced by positive, respectful and responsible behaviors. Seniors should exemplify good behavior, attendance, and academic standing. School staff fully anticipates responsible actions by each twelfth grade student; however, should infractions in attendance, discipline, and academic policies occur, the following procedure will be utilized (see both sides of this contract):

#### BEHAVIOR

**First referral:** The student and parent(s) will be required to meet with their administrator to discuss the cause for the referral. The student's behavior file will be "flagged" to indicate current discipline status. If necessary, the administrative cabinet will meet to review the infraction and determine if the student will be allowed to participate in any senior activity, including Commencement.

**Second referral:** The student has clearly violated the Senior Contract and the student will NOT be allowed to participate in any senior activity, including Commencement.

**Suspension:** Any senior who violates the Education Code and is suspended from school has clearly violated the senior contract. The student will NOT be allowed to participate in any senior activities, including Commencement.

#### ACADEMIC (GRADES)

Students must maintain a 2.0 GPA. If the student's GPA drops below a 2.0, the student will not be eligible for senior activities and will be required to comply with the interventions identified by a counselor, teacher, and/or administrator.

#### ATTENDANCE

Students must maintain a 95% or greater attendance rate. Students are required to attend school and must maintain 5% or less tardies and unexcused/uncleared absences. If a student does not maintain 95% or greater attendance, then the student will not be eligible for activities (including senior activities), dances, sport team participation and will be placed on an attendance contract.

#### CONSEQUENCES

Participation in the Canyon Springs High School senior activities is a privilege, not a right. The preceding requirements and guidelines must be met for participation in all senior activities.

Any senior who participates in any "Senior Ditch Day", will lose all senior activities including but not limited to Prom, Commencement, and Grad Night.

If any student violates this contract after paying for an event, **NO FEES WILL BE REFUNDED.**

Students who are not permitted to participate in senior activities may pick-up their diplomas in the Guidance Office between 8:00 a.m. and 11:00 a.m. on Friday, June 14, 2019 or anytime during summer office hours (8:00 a.m. to 3:00 p.m.) from the registrar in the Guidance Office.

All outstanding fees must be paid to the Bookkeeper on or before 12:00 p.m. on Monday, June 7, 2019, in order to attend Grad Night. No fees will be refunded for students who are removed from Grad Night for violations of the Senior Contract.
