Purpose

The Board supports and encourages the participation of parents/guardians and community residents to enhance the educational, co-curricular and extracurricular programs of the District.

Authority

The Board may adopt and enforce reasonable rules and regulations governing volunteers and their participation in the activities of the District.[\[1\]](#)

The Board directs that all volunteers shall be informed of conduct that is prohibited and the disciplinary actions that may be applied for violation of Board policies, administrative regulations, rules and procedures.[\[1\]](#)

All volunteers shall be expected to maintain professional, moral and ethical relationships with District students that are conducive to an effective, safe learning environment.[2]

Definitions

The following words and phrases, when used in this policy, shall have the meaning given to them in this section:

Certifications - refers to the child abuse history clearance statement (Act 151); the state criminal history background check (Act 34); and where applicable, the federal criminal history background check (Act 114), required by the Child Protective Services Law.[4][5]

Direct Volunteer Contact - the care, supervision, guidance or control of children and routine interaction with children.[3]

Person Responsible for the Child's Welfare - a person who provides permanent or temporary care, supervision, mental health diagnosis or treatment, training or control of a child in lieu of parental care, supervision and control.[3]

Routine Interaction - regular and repeated contact that is integral to a person's volunteer responsibilities.[3]

Assistive Volunteer - any individual who voluntarily provides services to the School District, without compensation, and who:

1. Works directly under the supervision and direction of any School District employee; and
2. Does not have routine interaction with students.

Examples of **Assistive Volunteers** include:

- Individuals who volunteer to assist in the planning or conducting of classroom celebrations.
- Concerts/Performance ushers.

Assistive Volunteers shall not have unsupervised contact with students and are not required to obtain Act 34, Act 151, or Act 114 clearances, but shall complete the Disclosure Statement Application for Volunteers and submit to a scan of his/her Driver's License, as required by Mars Area School District.

Independent Volunteer - any individual who voluntarily provides services to the School District, without compensation, and who:

1. Works under the general direction and supervision of any School District employee; and
2. Provides direct services to students or may, from time to time, have or may be reasonably expected to have unsupervised contact with students.

Examples of **Independent Volunteers** include:

- Individuals who volunteer at School-Affiliated Organization (SAO)-sponsored activities within school buildings.
- Classroom volunteers.
- PTO building volunteers.
- Individuals who help manage, officiate and/or perform functions ancillary to an athletic event or extracurricular activity.
- Volunteer tutors.
- Chaperones for field trips.

Independent Volunteers are required to obtain Act 34, Act 151 and Act 114 clearances.

Volunteer Coach/Sponsor - any individual who voluntarily provides services to the School District, without compensation, and who:

1. Works under the general direction and supervision of a coach and/or student activity sponsor employed by the School District, and
2. Directly supervises or instructs students engaged in the activity or may, from time to time, have or may be reasonably expected to have unsupervised contact with students.

Examples of **Volunteer Coaches/Sponsors** include:

- Individuals who volunteer to serve on the coaching staff of an athletic team.
- Volunteer athletic trainers and/or equipment managers.
- Choreographers, musicians, and other individuals who provide instruction to students in the marching band, school musicals, or school plays.

Volunteer Coaches/Sponsors are required to obtain a tuberculosis (TB) test as well as Act 34, Act 151 and Act 114 clearances. Tuberculosis (TB) test results and clearances will remain on file for five (5) years.

Delegation of Responsibility

The Superintendent or designee shall be responsible for the selection and management of volunteers and for ensuring compliance with Board policies, administrative regulations, rules and procedures.

At the discretion of the Superintendent or designee, a volunteer's service may be discontinued at any time.

The Superintendent or designee shall develop administrative regulations, forms and procedures to implement this policy and manage the selection, use and supervision of volunteers.

The District's Administration Office shall maintain a list of all volunteers approved by the Board, along with copies of all criminal history reports and clearances required by this policy. In addition, each Building Principal and the Athletic Office, if appropriate, shall maintain a list of the names and services provided by all volunteers who provide services in his/her respective buildings. These records shall be maintained for the duration of the period that the volunteer provides services to the District and for a period of five (5) years thereafter.

Guidelines

Each prospective Independent Volunteer and Volunteer Coach/Sponsor shall complete and submit a volunteer application.

The names of all Independent Volunteers and Volunteer Coaches/Sponsors shall be submitted for approval by the Board.

The names of all Assistive Volunteers shall be submitted for approval by the Building Principal or designee.

Under no circumstances shall a volunteer be considered an employee or independent contractor of the School District. A volunteer shall not receive wages, salary, or other valuable consideration for the performance of his/her services. Holding the position of a volunteer is not a right, but a privilege conferred upon by the Board, or acting through the Building Principal of each school, within the School District. The School District reserves the right to terminate the services or status of any volunteer at its exclusive discretion.

The role of volunteers is to assist, but not replace or assume the professional or paraprofessional responsibilities or authority of, the School District staff. Volunteers shall not provide regular instruction or educational training to students enrolled in the School District.

Under no circumstances shall volunteers be permitted to administer or enforce discipline upon students enrolled in the School District.

The Building Principal or designee shall assume general authority and responsibility over all volunteers serving at this site. The Athletic Director will assume general authority and responsibility over all athletic volunteers.

Upon approval, volunteers shall be placed on the list of approved volunteers.

Approval shall be required prior to beginning service as a volunteer.

Certifications

A student, eighteen (18) years of age or older, who is volunteering for an event or activity sponsored by the school in which the student is enrolled and occurring on the school's grounds, shall not be required to submit certifications except when the event or activity is for children in the care of a child-care service or the student will otherwise be responsible for the welfare of a child.[\[5\]](#)

All non-student volunteers shall be twenty-one (21) years of age or older.

All Assistive Volunteers shall complete the Disclosure Statement Application for Volunteers and submit to a scan of his/her Driver's License, as required by Mars Area School District. An Assistive Volunteer shall not be permitted to participate as a volunteer unless the completed Disclosure Statement Application for Volunteers is submitted and a scan of his/her Driver's License is completed.

Upon his/her initial appointment, an Independent Volunteer or Volunteer Coach/Sponsor shall be required to obtain and submit for Board approval an Act 34 Criminal History report, an Act 151 Child Abuse Clearance Statement, and an Act 114 FBI Clearance. Copies of valid clearances shall be re-submitted annually and said clearances shall be required to be renewed any time there is a break in continuous service for a period of more than one (1) school year.

An Independent Volunteer or Volunteer Coach/Sponsor shall re-submit valid Act 34, Act 114 and Act 151 clearances annually. Independent Volunteers and Volunteer Coaches/Sponsors shall obtain and submit new certifications every sixty (60) months when providing ongoing, uninterrupted service to the District.[\[7\]](#)

The costs of obtaining the required reports and clearances shall be the responsibility of the volunteer or any sponsoring parent-teacher organization or booster group.

A volunteer will not be approved if the criminal history or child abuse reports/clearances required by this policy evidence an offense which would preclude such individual from being employed in a Pennsylvania public school under Act 34, Act 114, or Act 151; in the event there is a conviction of the crimes enumerated in 24 Pa.C.S.A § 1-111; in the event that an individual is a registered sex offender on Megan's List; in the event that there is a conviction under the Controlled Substances, Drugs, Device, and Cosmetic Act; in the event there is a conviction for Resisting Arrest, Terrorist Threats, False Imprisonment, Arson, Contempt for Violation of Protection Order or Agreement, and related offenses, including, but not limited to, possession or dissemination of child pornography; any conviction for crimes involving domestic abuse or animal abuse; or any other offense involving moral turpitude and any other similar offenses.

Arrest or Conviction Reporting Requirements

Volunteers shall report to the Superintendent or designee, in writing, within seventy-two (72) hours, an arrest or conviction required to be reported by law or notification that the volunteer has been named as a perpetrator in a founded or indicated report pursuant to the Child Protective Services Law.[\[6\]](#)

The Superintendent or designee shall immediately require Volunteers to submit new certifications if the Superintendent or designee has a reasonable belief that the volunteer was arrested for or has been convicted of an offense required to be reported by law, was named as a perpetrator in a founded or indicated report, or has provided written notice of such occurrence.[\[6\]](#)

Failure to accurately report such occurrences may subject the Independent Volunteer and Volunteer Coach/Sponsor to disciplinary action up to and including denial of volunteer service and criminal prosecution.[\[6\]](#)

Child Abuse Reporting

All volunteers who have reasonable cause to suspect that a child is the victim of child abuse shall make a report of suspected child abuse in accordance with applicable law, Board policy and administrative regulations.[8][9]

Supervision

Each volunteer shall be under the supervision of a designated school administrator, teacher or other member of the school staff.

Training

Volunteers shall attend orientation and training sessions, as appropriate to the nature of their volunteer service. When training is provided for school employees relating to the legal obligations of employers and educational institutions, consideration shall be given to which volunteers should also receive that training.[10][11][12][9]

Confidentiality

No volunteer shall be permitted access to confidential student information unless the supervisor has determined that such access is necessary for the volunteer to fulfill his/her responsibilities. Volunteers with access to confidential student information shall maintain the confidentiality of that information in accordance with District policies and procedures and applicable law. If a volunteer has questions about the confidentiality of student information, the volunteer should consult with the Building Principal.[13]

Each volunteer shall affirm in writing that he/she has been provided with a copy of, has read, understands and agrees to comply with this policy.

I understand that if the person responsible for employment decisions or the administrator of a program, activity or service has a reasonable belief that I was arrested or convicted for an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law, or was named as perpetrator in a founded or indicated report, or I have provided notice as required under this section, the person responsible for employment decisions or administrator of a program, activity or service shall immediately require me to submit current certifications obtained through the Department of Human Services, the Pennsylvania State Police, and the Federal Bureau of Investigation, as appropriate. The cost of certifications shall be borne by the employing entity or program, activity or service.

I understand that if I willfully fail to disclose information required above, I commit a misdemeanor of the third degree and shall be subject to discipline up to and including denial of a volunteer position.

I understand that certifications obtained for the volunteering purposes can only be used for that purpose and cannot be used for employment purposes.

I understand that the person responsible for employment decisions or the administrator of a program, activity or service is required to maintain a copy of my certifications.

I hereby swear/affirm that the information as set forth above is true and correct. I understand that false swearing is a misdemeanor pursuant to Section 4903 of the Crimes Code.

DISCLOSURE STATEMENT APPLICATION FOR VOLUNTEERS

Required by Mars Area School District, pursuant to the Child Protective Service Law
23 Pa. C.S. Section 6344.2 (relating to volunteers having contact with children)



The following Mars Area School District “Disclosure Statement Application for Volunteers” form is to be completed by anyone who has been a Pennsylvania resident for less than ten (10) years and is applying to serve as an “assistive volunteer” within Mars Area School District. An assistive volunteer is “any individual who voluntarily provides services to the School District without compensation, and who works directly under the supervision and direction of any School District employee; and, does not have routine interaction with students,” as stated in District Policy 916 Volunteers. Assistive volunteers may include those who volunteer to assist in the planning or conducting of classroom celebrations or as concert/performance ushers.

The Pennsylvania Child Protective Services Law requires that “assistive volunteers” be “a resident of Pennsylvania during the entirety of the previous ten-year period.” However, Mars Area School District is aware that, as this is a growing District, many of those applying to serve as assistive volunteers are entering the District from other states and may not meet the legal requirement. Therefore, in good faith, the District has developed the following form to accommodate those individuals interested in applying to serve as an assistive volunteers and who have been a Pennsylvania resident for less than ten (10) years.

By signing this form, applicants acknowledge that all information has been understood and that all requirements, other than the 10-year Pennsylvania requirement, are met. Each applicant is also required to submit to a scan of his/her driver’s license to verify that he/she is not listed on the National Sex Offender Registry, as required under District Policy 916 Volunteers

I understand that certifications obtained for the volunteering purposes can only be used for that purpose and cannot be used for employment purposes.

ARREST, CONVICTION & CHILD ABUSE REPORTING REQUIREMENTS

Independent Volunteers and Volunteer Coaches/Sponsors shall report to the Superintendent or designee, in writing, within seventy-two (72) hours, an arrest or conviction required to be reported by law or notification that the volunteer has been named as a perpetrator in a founded or indicated report pursuant to the Child Protective Services Law.

I understand that if I am arrested for or convicted of an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law as listed above, or am named as perpetrator in a founded or indicated report, I must provide the administrator or designee with written notice not later than 72 hours after the arrest, conviction or notification that I have been listed as a perpetrator in the Statewide database.

I understand that if the person responsible for employment decisions or the administrator of a program, activity or service has a reasonable belief that I was arrested or convicted for an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law, or was named as perpetrator in a founded or indicated report, or I have provided notice as required under this section, the person responsible for employment decisions or administrator of a program, activity or service shall immediately require me to submit current certifications obtained through the Department of Human Services, the Pennsylvania State Police, and the Federal Bureau of Investigation, as appropriate. The cost of certifications shall be borne by the employing entity or program, activity or service.

I understand that if I willfully fail to disclose information required above, I commit a misdemeanor of the third degree and shall be subject to discipline up to and including denial of a volunteer position.

I understand that certifications obtained for the volunteering purposes can only be used for that purpose and cannot be used for employment purposes.

I understand that the person responsible for employment decisions or the administrator of a program, activity or service is required to maintain a copy of my certifications.

I hereby swear/affirm that the information as set forth above is true and correct. I understand that false swearing is a misdemeanor pursuant to Section 4903 of the Crimes Code.
