



**Board Briefing  
ILA Charter Information**

The ILA Charter has submitted three charter petitions that were denied by the SLV school district due to inadequacies in required elements, an unsound educational program, and deemed demonstrably unlikely to succeed. Specific information about each denial is provided in the following:
