**What happens now that UCPS is closed because of COVID-19?**

UCPS will operate using Non-Traditional Instruction (NTI) days starting Monday March 16 and extending through Friday April 17th. This will be a total of 4 weeks of NTI instruction (April 6-10 is still scheduled as Spring Break and we will not have NTI instruction that week).

For NTI day assignments, students in all grades K-12 will complete a mix of paper packets and online work. Elementary students will have mostly paper packets; middle & high school students will have mostly online lessons.

All schools will be closed for this five-week period based on the Governor’s recommendation.

**Staff Availability**

Our schools’ closure is a response to a request from the Governor to close all schools to lessen the spread of the pandemic COVID-19. This is a matter of public health and not only are our buildings closed to students, but to staff also. **Teachers and staff will not be on-site.**

Teachers will provide an online presence to help students with NTI assignments. You may contact your child’s teacher by email or other contact information the teacher has provided.

**Happy Packs**

Happy Packs will be available on Fridays for the families who regularly receive Happy Packs and can be picked up during the lunch serving time.

**FRYSC Services**

As part of the public health measures we are taking to prevent the spread of COVID-19, our FRYSC coordinators will not be on-site each day or doing home visits. For emergency needs, you can reach your school’s Family Resource Coordinator by email. The services they can offer will be very limited.
