DECATUR CITY SCHOOLS POLICY CONSENT/RELEASE FORM

We have read and agree to abide by the Decatur City Schools Tobacco, Alcohol, and Drug Policy (TAD) for Student Drivers and Students participation in Competitive Extracurricular Activities. We agree that the undersigned student will submit to tobacco, alcohol, and drug tests at any time as a condition to the student's initial or continued participation in competitive extracurricular activities or drives or parks a motor vehicle on

school property or any other site off campus during school hours at which a student is participating or observing any school activity. We authorize the laboratory or medical provider to release test results to the Decatur City Schools' Medical Review Officer (MRO). We authorize the MRO to release final test results to the undersigned parent/guardian and to the Decatur City Schools employees whose duties require them to know. We also authorize Decatur City Schools or its MRO to release any test related information, including positive results:

- a) As directed by the undersigned parent's guardians and student's specific, written consent authorizing release of the information to an identified person.
- b) To the decision maker in a lawsuit, grievance, or other proceeding initiated by or on behalf of the undersigned student.
- c) As otherwise required by law or legal process. We understand that this agreement does not limit student's right to terminate or to be terminated from participation on competitive student activities or driving privileges.

We understand that unless the undersigned parents or guardians contact Decatur City Schools Drug Testing Coordinators after the first year, and make a written request to remove the student's name and social security number from the testing pool, the student's name will automatically be reentered into the testing pool each year.
