EXAMPLES OF DUTIES

Tutors students in the after school program, especially intervention and acceleration for students below grade level; tutors students in core curricular subjects, and assists with homework; tutors and provides intervention, prevention, and acceleration for students testing below grade level; provide enrichment, social, and recreational activities for students in the after school program; identifies unique student needs and collaborates with other team members; helps assess students regularly in accordance with Norwalk – La Mirada Unified School District guidelines; collaborates with Norwalk – La Mirada Unified School District team members to improve own and others' instructional practices; shares and uses best practices; actively participates in professional development activities offered by the district and region; supports classroom systems/procedures and helps manage student behavior to ensure all students are safe and fully engaged in learning; supports a school-wide culture of high expectations that includes college and career preparation for all students; demonstrates knowledge of, and supports, Norwalk – La Mirada Unified School District mission, vision, value statements, standards, policies and procedures, operating instructions, confidentiality standards, and the code of ethical behavior; and performs other related duties as required and assigned.

MINIMUM QUALIFICATIONS

Knowledge of:

Developmental stages of children; methods to increase student responsibility and build self esteem; techniques to motivate students to learn; strong written and verbal communication skills; academic, recreational, and social activities appropriate for age level of children.

Ability to:

Work effectively in one-to one situation with students; be sensitive to the feelings and needs of children ranging in age from elementary through middle school; follow directives and meet deadlines, attend and demonstrate understanding of the training; understand and follow oral and written directions; motivate students through the use of praise and encouragement; and willingness to reflect and improve practice; collaborate with colleagues, parents and community in a professional manner.

Education:

Proof of High School Diploma or equivalency and AA Degree or 48 college units or pass Paraeducator Exam.

Experience:

Working with children such as volunteering in a classroom, recreational leader, coaching a team, sport or activity; supervising them on the playground; and one to one tutoring is desirable.

Desirable Qualifications:

Ability to communicate effectively and professionally with adults and children; and Bilingual/Spanish is desirable.
