- The following student policies are brought to you by Forethought Consulting resulting from the 2018 Louisiana Legislative Session.

A. Behavioral Health Services for Students File: JGCF (New)

Private behavioral health service providers are allowed to have access to students at school during the school day if the parent or legal guardian has requested such services.

Procedures and forms for this policy have been developed.

Effective January 1, 2019

B. Dismissal of Employees File: GBN

Act 238 amends this policy addressing the dismissal of tenured bus operators by following the same procedures as tenured certificated personnel. These procedures are included in *Employee Discipline File: GBK*.

Act 634 also amends this policy calling for the dismissal of an administrator, teacher, or substitute teacher submitting fraudulent documentation to BESE or LDOE in an application for a teaching certificate and/or cheating on a state assessment as determined by BESE.

Act 634 became effective July 1, 2018.

C. Employee Discipline File: GBK

Act 238 revises this policy providing bus operators with the same hearing procedures as tenured teachers. A subheading in this policy has been added to identify the location of the hearing procedures.

Act 238 became effective May 2018 upon signature of the Governor.
