Student/Parent Agreement 2018-2019 Campus Policies

Instructions:

All students and parents (or legal guardian) must read and review the program requirements and policies. This form must be signed by the student and parent (or legal guardian) and returned to the COCISD Technology Help Desk.

Program Requirements

_____ The Student and Parent (or Legal Guardian) must sign and return this Student/Parent Agreement.

_____ Payment of the \$50.00 Deposit. This deposit is refundable at the end of your enrollment at Coldspring-Oakhurst High School if no Chromebook damage has occurred.

_____ If repairs need to be made to the Chromebook at any time during your child's high school career, another deposit will be required.

Student Agreement

_____ I will bring my COCISD issued device to school **EVERY** day that I am in attendance.

_____ I will not use the device for non-academic purposes during school hours (7:45AM-3:30PM); (For example: games; downloads; chat rooms; instant messaging; viewing websites not related to the assignment; etc.)

_____ I will charge the battery daily and will NOT loan out the device, power adapter, or other materials to other individuals.

_____ I will transport the device in its' protective bag or case. The bag or case will be securely closed before transporting the device to another location. I will be careful when storing the device (for example, in a backpack with books) since excessive pressure on the device may cause damage. If I must leave the classroom, I will take the device with me.

_____ I will keep the bag or case off the floor where it could be stepped on or tripped over. I will keep food, beverages and other liquids away from the device since they may cause damage.

_____ I will not use the device while on the bus or in a moving vehicle.

_____ I will not disassemble any part of the device or attempt any repairs. If my device includes a keyboard, and should a key pop off the keyboard or any other part become loose or detached, I will bring it to the Library Help Desk to be reattached.

_____ I will not deface the device or it's protective bag or case in any way. This includes, but is not limited to, attaching stickers, marking, painting, drawing, or marring any surface of the device, bag or case.

_____ I understand that regulations have been addressed in the Student Code of Conduct to emphasize that obscene language and/or materials, including music, screensavers, backdrops, and/or pictures are prohibited. If such items are found, I understand that my device will be immediately erased (re-imaged) and I could face disciplinary actions.

_____ I understand that my device is subject to inspection by a COCISD faculty member at any time without notice and remains the property of Coldspring-Oakhurst Consolidated ISD.

_____ I will follow the expectations outlined in the Student/Parent Agreement and the Acceptable Use/Responsible Use Policy while at school, as well as outside the school day.

_____ I assume full responsibility of my Coldspring-Oakhurst CISD issued device.

_____ I understand that I am required to submit a report for Damage or Theft to the Library Help Desk within 72 hours of the Theft or Damage incident.

Parent Agreement

_____ I acknowledge that my student and I will follow the expectations on this Student/Parent Agreement, and the COCISD Acceptable/Responsible Use policy and that a violation of these policies could result in the student facing disciplinary action and/or suspension of further participation in the device check-out program.

_____ I will be responsible for the monitoring of my student's use of the Internet when he/she is not at school.

_____ I acknowledge that fraudulent reporting of theft will be turned over to the police.

_____ I agree to immediately return the District device, protective bag and/or case and any peripherals in good working condition upon request or upon withdrawal from school. Device must be turned in 2 weeks prior to the last day of school, or prior to withdrawing a student from enrollment.

Terms of Agreement

Your coverage AND right to the use and possession of the property terminates two weeks prior to the last calendar day of this school year, unless terminated earlier by the District, or if you withdraw your child prior to the end of the school year. All district property issued to the student must be returned upon request or upon withdrawal.
