Future Ready Index: What is it?

- One stop location for comprehensive information about school
 - Assessment scores (PSSA, PVAAS, SAT/ACT, CTE measures, Keystone) attendance, graduation rates, curriculum rigo.
- Why the change?
 - Act 82 of 2012: Statewide educator effectiveness.
 - Required PDE provide a building level score...AKA School Performance Profile (SPP).
 - Approximately 85% of the SPP score was/is based on assessment scores.
 - Schools will still receive an SPP score for 82-1, but will not be made public.
 - Lead to outside stakeholders such as media to dub this as an absolute way to rank schools.
 - Various stakeholders began to pushback: Holistic approach, less emphasis on testing, etc.
- Future Ready PA Index is that alternative.

Future Ready PA Index: Framework

- Federal and State influences
- Federal: ESSA
 - ESSA requires that under a process of "Annual Meaningful Differentiation" states utilize 6 indicators: 4 are mandated by the Federal Government, which are:
 - Percent proficient and Advanced on exams (PA uses PSSA, PASA, and/or Keystones).
 - Meeting annual growth expectations (PVAAS).
 - English Language Proficiency
 - Graduation Rate
 - PDE/State chose the remaining 2, which are:
 - Chronic Absenteeism
 - Career Standards Benchmark
