

SVF iPad Oath

1. I will follow the St. Vincent Ferrer Acceptable Use Policies (AUP) for technology.
2. I will follow classroom rules for the iPad set up by my classroom teachers.
3. I will be on task in class and am aware of the off task consequences (delineated in this document).
4. I will exclusively use apps and programs during class that are appropriate to the in-class assignments.
5. I will handle my iPad carefully and respectfully.
 - I will never leave the iPad unsecured
 - I will never loan it out to another individual
 - I will keep food and beverages away from my iPad
 - I will never touch another student's iPad
 - I will not put stickers on the iPad Case
 - I will not deface the charging block or cord with stickers, tape or marker
6. I will ask permission prior to recording audio and taking photos/videos of my classmates and staff members.
 - I will not email any photos/audio of students, teachers, or staff members to others without prior permission.
7. The camera is for educational use only and should not be used during class without teacher approval. All photos must be school appropriate.
8. I will keep the School Approved Wallpaper on my iPad at all times.
9. I understand that my iPad is the property of St. Vincent Ferrer Catholic School and will be routinely inspected by teachers and administrators at any time without notice.
10. I will use my iPad as a Learning Device.
 - I will not text or play unapproved games during instructional time.
 - I will not download any applications, photos, music, etc. that impedes the device being used for educational use.
 - During class, I will stay in my Apple Classroom environment at all times. If I am having a technical issue, I will notify my teacher immediately.
11. I will not delete or tamper with profiles and configurations on my iPad (including but not limited to):
 - I will not jailbreak (the process of removing hardware restrictions on iOS, Apple's operating system) my iPad
 - I will not change the wallpaper background on my iPad
 - I will not remove any Airwatch MDM Apps (Self-Service, Agent, & SVF App Catalog)
12. I will report loss or damage immediately to Ms. Gustinelli, the IT Administrator.
 - A \$60 fee will be assessed for any iPad that is **damaged or lost**.

Consequences

1. St. Vincent Ferrer School is not responsible for any additional peripherals students bring to school such as battery chargers, keyboards, etc.
2. If a student is not handling their iPad respectfully as outlined in the Oath above, a **Notice of Concern** will be issued.
3. If a student forgets their iPad, a Notice of Concern will be sent home and their grade will be reflected accordingly. Students will not be able to borrow an iPad. If this happens 3 times within a quarter a **Conduct Referral** will be issued.
4. If a student's iPad requires repair through AppleCare or Secondary Insurance, students will not be able to borrow an iPad or bring in an outside iPad or computer.
5. Students are not to touch or share their iPads with other students. A **Conduct Referral** will be issued for this infraction.
6. If students are not on the correct apps or websites during class or leave their Apple Classroom environment, a **Notice of Concern** will be issued. If this happens 3 times within a quarter a **Conduct Referral** will be issued.
7. Students must ask permission prior to recording audio and taking photos/videos of my classmates and staff members. A **Conduct Referral** will be issued for this infraction.
8. The camera is for educational use only. Any student violating the camera policies listed above will receive a **Notice of Concern** and will lose access to the camera for a period of 1 week. Additional infractions will result in a **Conduct Referral and Detention**.
9. Altering the School approved Wallpaper will result in a **Notice of Concern**.
10. Deleting or tampering with profiles and configurations on iPads will result in a **Conduct Referral**.
11. Any download of blacklisted apps such as games and social networking, will result in a **Conduct Referral** and the iPad being wiped. If this occurs students must see Ms. Gustinelli immediately.

Please be advised that this document can be updated at any time as needed in an effort to clarify the iPad Oath and St. Vincent Ferrer Acceptable Use Policy (AUP).
