MINUTES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION

DATE: MAY 10, 2010 7:30 p.m.

The Board of Education of the East Windsor Regional School District held a Regular meeting on MONDAY, MAY 10, 2010 at 7:30 p.m. in the Hightstown High School Cafeteria located at 25 Leshin Lane, Hightstown, NJ.

ITEM 1. WELCOME

Board President Alice Weisman called the meeting to order at 7:30 p.m. and read the Open Public Meeting Act Statement as follows:

“Written advance notice of this meeting has been given in accordance with law. Minutes of this meeting are being kept by the Board Secretary and will be made available promptly to any member of the public requesting them from the Board Secretary at the Administration building 25A Leshin Lane, Hightstown, NJ. Minutes will be provided at cost and in accordance with Board policy.”

Ms. Weisman asked “Are there any Board members present who believe this meeting to be in violation of the Open Public Meeting Act?” No one objected. “There being none, we may proceed.”

The Board president asked those present to join in the pledge of allegiance to the flag.

ITEM 3.A APPROVAL OF AGENDA

Having read the material received, Mr. Ettman moved, seconded by Ms. Fallon, to approve the agenda.

ITEM 3.B RESOLUTION FOR CLOSED SESSION

Mr. Ettman moved, seconded by Ms. Lloyd to approve the following resolution:

BE IT RESOLVED, that the Board of Education of the East Windsor Regional School District will hold two closed sessions during its regular meeting on May 10, 2010. These closed sessions concern:

Personnel matters, Litigation, Contract matters, and Attorney /Client Privilege. Minutes will be available in accordance with Board policy when the need for confidentiality no longer exists.

On a roll call vote of the Board, Motion to approve was carried unanimously.

ITEM 4. PROCLAMATION: SPECIAL EDUCATION WEEK

Ms. Weisman read the Proclamation for Special Education Week.

WHEREAS, the public school districts and the private schools of New Jersey make a major contribution to the public welfare by preparing thousands of exceptional persons to participate as citizens of this state and as members of society; and

WHEREAS, New Jersey's special education programs produce success stories every day as children with the guidance and support of dedicated teachers and parents, overcome obstacles to achieve to their fullest potential; and

WHEREAS, New Jersey has been a nationwide leader in providing services to students with physical and learning disabilities; and

WHEREAS, New Jersey's schools annually serve over 244,000 special education students; and

WHEREAS, the New Jersey School Boards Association and the Association of Schools and Agencies for the Handicapped have sponsored Special Education Week in New Jersey since 1985; and

WHEREAS, the theme of this year's state celebration is "Painting a Better Tomorrow"; and

WHEREAS, our school district is fortunate to have dedicated teachers, child study team members, support staff and parents who work together for the benefit of our community's special education children.

NOW, THEREFORE, I, Alice Weisman, President of the Board of Education, do hereby proclaim May 9 through May 15, 2010, as Special Education Week in New Jersey and in the East Windsor Regional School District.

Action: Mr. Ettman moved, seconded by Ms. Fallon to approve the proclamation for Special Education Week. On a roll call vote of the Board, motion to approve was carried unanimously.

ITEM 5. ANNOUNCEMENTS

Mr. Dzwonar gave an update of the budget process. 37 positions representing \$2.9 million dollars are on the agenda tonight for elimination. It is important to preserve what we can. The East Windsor Management Association agrees to a salary freeze. In addition, non bargaining employees are freezing their salaries. The EWMA and non-bargaining staff salary freeze represents approximately \$200,000.

There is no commitment from EWEA for a salary freeze.

The Race to the Top application status was presented.

Ms. Weisman seconded that many of the initiatives of Race to the Top have been performed by the EWRSB in the prior six years. We have been doing these items with limited budget increases. Now we will lose resources for these and other activities due to budget cuts.

Mr. Ettman agreed that cutting budgets across the board penalizes districts for their initiatives. It is mean spirited. Mr. Ettman expressed frustration at the Governor.

ITEM 6. FIRST OPPORTUNITY FOR PUBLIC COMMENT

Stephen Bryant of East Windsor gave an update on the Community Unity day for Hightstown and East Windsor. Mr. Bryant extended an invitation to their next meeting on May 12, 2010. The Board expressed their gratitude.

Mario Ribeca of East Windsor is an employee of the district and a 15 year resident. He commented on the RIF (Reduction in Force) letter that he received. He read from a letter highlighting the commitment of the entire maintenance staff and requests reconsideration of his own and his fellow workers termination.

ITEM 7. FIRST OPPORTUNITY FOR BOARD MEMBERS COMMENTS

Ms. Fallon commented on the progress of the past 5 years including maintenance and custodial staff. Their efforts are appreciated.

Mr. Laverty commented on the upcoming NJSBA Delegate Assembly meeting on May 15, 2010.

The agenda items for this meeting will include enrichment program costs, for economically disadvantaged and school harassment, intimidation and bullying policies.

Ms. Weisman announced that the Governors Teacher's Awards Ceremony is Thursday June 3, 2010.

The teacher's names were read.

G. AGREEMENT TO PARTICIPATE IN THE EWING TOWNSHIP, NJ CONSORTIUM, JAMES MADISON SEMINAR ON TEACHING AMERICAN HISTORY

H. AWARD OF GAS SUPPLY CONTRACT TO HESS CORPORATION

On October 24, 2005 the East Windsor Regional School District approved a resolution binding the District to purchase natural gas supply services through **ACES**, (Alliance for Competitive Energy Services.) This Resolution authorized ACES to obtain bids for natural gas service on the District's behalf. The current gas supply contract expires on May 31, 2010. After a rigorous bidding process, ACES has awarded the winning bid and new contract to HESS Corporation to provide natural gas service to the East Windsor Regional School District for a term of 24 months, from June, 2010 through May, 2012.
