If a student/family is found to be in a homeless situation, the McKinney-Vento Homeless Education Act allows enrollment without a permanent address. **Not all Shared Housing situations are considered homeless.** If you feel your situation would qualify under this provision, please complete the **Questionnaire Family/Student Domicile** form instead of the Shared Housing form and submit to the school's office staff.

- I understand that I can be charged with a Class 4 misdemeanor for knowingly making a false statement concerning the residence of a child in a particular school division or school zone.
- I understand that a home inspection may be made to verify residency.
- I understand that if the Shared Housing is in an apartment complex, the manager will be contacted for verification.
- I understand if the documentation listed below is not received within 30 days, my child(ren) will be withdrawn.

By signing below, I affirm that the information above is true and accurate under penalty of Section 22.1-3.2 of the Code of Virginia.

**For proof of residency, a current driver's license or DMV ID is required along with one of the following: bank statement, vehicle registration, paycheck stub, or voter registration card with current address. These documents must have the address you are currently claiming as your residence.**

This permission has to do only with registration for classes. Any student who transfers from one school to another within the county, without a corresponding change of address, will be ineligible to participate in any VHSL activity for a period of one calendar year from the date of enrollment.
