Please consider the following as an invitation to bid on Bakery items for the Durango School District, school year 2019-2020 with the possibility of a two year extension into 2020-2021 and 2021-2022. This will be in accordance with terms and conditions established in this bid. All bids received after the time specified will not be opened or considered. The vendor is responsible for having their bid in on time, at the above location. Telephone amendments, faxed bids and emailed bids will not be accepted.

All sealed bids must be addressed to Durango 9-R School District, Student Nutrition Services, 2390 Main Avenue, Durango, CO 81301 and received by Wednesday, June 26, 2019. An agent authorized to enter into an agreement must sign bid.

**The new school food service regulations require ALL breads to be whole grain. Nutrition labels must be provided to prove the products are whole grain. Please provide product formulation statements for all bid items.**

Initial order will be sent to the winning bidder prior to August 8, 2019 school year start up. All subsequent orders will be placed in accordance with the system agreed upon by both parties.

Deliveries will be at least weekly to each school in the Durango School District. Ft. Lewis Mesa Elementary School and Sunnyside Elementary School may be dropped off at the District Warehouse. An address and contact name for all cafeterias will be furnished with the bid award. Vendor must notify the district in advance of delivery if unable to deliver items as ordered. District 9-R reserves the right to reject any or all bids and to cancel the contract at any time should the vendor not meet the standards for quality or service. Unless otherwise stated, any contract entered into as a result of this bid may be cancelled by either party upon 30 day written notice of the effective date of cancellation. Cancellation may be in whole or part.

The prices for this bid will be considered in effect August 1, 2019 through June 30, 2020. The contracted price may not be changed unless mutually agreed upon in writing by both parties.
