1. Students must be **16** years of age before **Friday February 08, 2019**.
2. Effective February 22, 2010, New York State Junior Learner Permit holders must have completed 50 hours of supervised driving (15 hours must be after sunset) and must possess a permit for six months before becoming eligible to take a road test. The required supervised driving hours do not apply to 17-year old permit holders who have completed a certified Driver Education course and who present a valid Student Certificate of Completion (MV-285) at the road test, since they will be issued a senior license (Class D or M) upon passage of the road test.
3. The course is approved by the New York State Department of Education and Motor Vehicles.
4. **Students must meet the 24-hour classroom and the 24-hour automobile (6 hours at the wheel and 18 hours observation) instruction requirements for their certificate of completion. ONLY APPROVED CLASS ABSENCES will be rescheduled. Certificates of completion are not issued if the exact 48-hour requirement is not completed.** Certificates of completion will be issued **at the end of the course**.
5. Vehicles used contain all required safety equipment and all are air-conditioned.
6. Full payment must accompany this application. No partial payments will be accepted.
7. Special schedule requests will be accommodated on a first come, first served basis.
8. Present the form below, completed in its entirety, including signatures required, to the Main Office of St John's Preparatory School between the hours of 8:30 AM and 3:00 PM when school is in session. Mailed applications are accepted if accompanied by fee. Checks must be made out to ST JOHN'S PREPARATORY SCHOOL, Attention: Drivers Education **OR** payment can be made with a credit card **for an additional \$10 fee**.
9. Registration can be completed by mail, telephone or in person. To guarantee availability, please register as soon as possible.
10. When filling out application form, use name as it appears on the applicant's birth certificate. **Do not use nicknames**.
11. **Classes begin on Friday February 08, 2019 and are scheduled to conclude on Friday June 08, 2019**
12. Road test arrangements are not included and are the responsibility of the student.
13. Parent/Guardian with the student **MUST ATTEND a Mandatory Orientation on Friday January 25, 2019 at 6:00 pm**.
14. **Students are notified as to their exact instruction times at the orientation.**
