Volunteer Disclosure Release Form

This is to inform you that as part of our procedure for processing your volunteer application, Golden Rule Schools will use TDPS Crime Records Service.

This agent will provide criminal background information that will determine eligibility to serve as a volunteer. Golden Rule Schools will not accept a person with a felony conviction or a deferred adjudication of a felony volunteer. A person with misdemeanor convictions or deferred adjudications against persons or property including prostitution or drugs will not eligible to volunteer.

Any person convicted for crimes of a sexual nature, designated as a sexual predator/offender, or under consideration by any court for being declared a sexual predator/offender will not be eligible to volunteer.

Golden Rule schools inc. may make an investigative report in which information is obtained through personal interviews with family members, business associates, friends, neighbors, educational institutions, courts, law enforcement agencies or other third parties with whom you are acquainted. This information will include inquiries at to your characteristics or mode of living, whichever is applicable.

By signing the document below you are releasing any and all persons, companies or others from any liability whatsoever for this purpose.

You have the right to make a written request, within a reasonable period of time, for complete disclosure of additional information concerning the nature and scope of the investigation.
