

June 2, 2016

The Oneida Special School District Board of Education met in regular session on Thursday, June 2, 2016, at 6:00 p.m. in the Oneida High School Library. The following members were present: Dr. Danny Cross, Mrs. Dorothy Watson, Mr. Brom Shoemaker, Mr. Mark Matthews and Dr. Nancy Williamson. Also in attendance were Director Ann Sexton and Lori Marcum, secretary.

Chairperson Williamson called the meeting to order. Aidan May, Maddie May, Carlie Duncan and Kendall Duncan led those in attendance in the pledge of allegiance.

Chairperson Williamson presented the board agenda for consideration with one addition and two (2) items would be removed. The addition would be added as Item 12 under Business Before the Board and is a fundraiser request from OHS Cheerleaders for selling T-Shirts and Hoodies. The two items removed from the agenda were the Differentiated Pay Scale for 2016-2017 and the Creation of a New Position (Attendance /Transportation / Maintenance / Testing Evaluation and Scheduling) Mrs. Watson made a motion, with a second by Dr. Cross, to approve the board agenda as amended. Vote was taken and motion carried.

Chairperson Williamson then presented the consent agenda for board approval. Mr. Shoemaker made a motion, with a second by Mr. Matthews, to approve the consent agenda as follows. Vote was taken and motion carried.

Chairperson Williamson presented the E-PLAN Consolidated Application (EESA, IDEA and CTE) for board approval. Mrs. Watson made a motion, with a second by Dr. Cross, to approve the E-PLAN Consolidated Application. Vote was taken and motion carried.

Chairperson Williamson then presented the Continuing Budget Resolution for Fiscal Year Ending June 30, 2016 for board approval. Dr. Cross made a motion, with a second by Mr. Shoemaker, to approve the Continuation Budget Resolution as presented. Vote was taken and motion carried.

Chairperson Williamson then presented the OT/PT bids for board consideration. Ms. Payne noted that there was one bid received from Grace Rehabilitation who has provided services for several years. She also noted that prices for services have not changed. Mrs. Watson made a motion, with a second by Dr. Cross, to award OT/PT service contacts to Grace Rehabilitation for the 2016-2017 school year. Vote was taken and motion carried.

3. The 2016 annuals were delivered and thanks to Sandy Martin for a wonderful job.
4. OHS is currently working on schedules and assignments.
5. GCA and maintenance crews are working to get the facilities cleaned and in working order.
6. Enrollment is up approximately 25 students.
7. OHS has 1 student in summer school this year.
8. ACT scores are up almost 1 point to 20.05.
