Mrs. Murdaugh moved to accept the Superintendent's position of rescinding Mrs. Wilson's resignation based on her withdrawal. The Board is reinstating the assistant principal position that was cut for budget reasons. Mr. Murdaugh seconded the motion. The motion was adopted unanimously.

Mrs. Murdaugh moved to accept the resignation of Craig James. Mr. Strother seconded the motion. The motion was adopted unanimously.
